

RESOLUTION NO. CC-2510-075

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL
YEAR 2025-2026 BUDGET MODIFICATION TO ALLOCATE
\$500,000 FROM THE CALIFORNIA COASTAL COMMISSION
FOR LOCAL COASTAL PROGRAM ASSISTANCE**

WHEREAS, it is the intention of the City Council of Redondo Beach ("City Council") to review the adopted budget from time to time;

WHEREAS, the City of Redondo Beach's adopted budget needs to be modified to allocate monies from outside sources to fund necessary expenditures;

WHEREAS, on October 7, 2025, the City of Redondo Beach ("City") adopted a resolution to accept a grant from the California Coastal Commission;

WHEREAS, pursuant to this grant agreement, the California Coastal Commission will grant \$500,000 to the City to retain a qualified consultant to support the necessary technical studies across the coastal zone and help reorganize the City's LCP to improve organization and clarity and help the city comply with the requirements of SB 272;

WHEREAS, since the adoption of the budget, additional, previously unbudgeted revenue has been identified, which must be allocated to fund the necessary improvements; and

WHEREAS, the grant award by the California Coastal Commission is not included in the adopted Fiscal Year 2025-2026 Budget, and a budget modification is necessary to allocate these funds.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The amounts allocated in the Fiscal Year 2025-2026 Budget need to be modified to recognize grant award received during the year; and, upon recommendation of the City Manager, the budget as adopted for Fiscal Year 2025-2026 is modified as follows:

Five hundred thousand dollars (\$500,000) shall be appropriated to the Intergovernmental Grants Fund in the Waterfront and Economic Development Department

SECTION 2. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2025-2026 in accordance with the above modification.

SECTION 3. This Resolution shall take effect immediately upon its adoption by the City Council.

SECTION 4. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
