Shakespeare by the Sea/Little Fish Theatre will promote health and wellness in the Community by promoting a culture of connection, delivering live shared experiences to a multigenerational audience of participants through programs such as summer Shakespeare festival, publicly open performances by Little Fish Theatre who will also offer dedicated seats for the District and its tenants to use for drama therapy, youth from allcove, older adults from Silverado Memory Care facility, etc.

LEVEL II: \$365 LEVEL II: \$805

DEFINITIONS:

LIVE ENTERTAINMENT: Shall mean any presentation, act, reading, performance, musical rendition, or recitation, involving one or more live individuals intended to divert, amuse, explain, focus, or attract the attention of persons observing such activity. Live entertainment includes, but is not limited to: plays, musical concerts, spoken word performances, disc jockeys, MCs, hosts performance artists, magic shows, escape artists, circus acts, live animal acts, dance performances, and other, similar attractions. The term shall also encompass the provision of dancing for, or with patrons whether to live or recorded music, when Title 4, Chapter 2, Article 3 of the Redondo Beach Municipal Code does not apply to such activity.

Live entertainment shall not include: street performers; private non-commercial parties held on private property for which no admission is charged, and which are not intended to generate profit; lectures presented in fully enclosed buildings; or the use of recorded background music or television provided for the enjoyment of patrons.

EXTRAORDINARY LAW ENFORCEMENT OR PUBLIC SAFETY SERVICES: Shall mean services provided by the City of Redondo Beach which require more than two units to adequately respond to the situation, or that are beyond the course and scope of the services routinely provided to other businesses and citizens, and stretch the resources of the responding agency beyond those normally available for response.

ENTERTAINMENT PERMIT REQUIRED:

Any live entertainment conducted within the City boundaries shall require an Entertainment Permit, pursuant to Title 4, Chapter 17 of the Redondo Beach Municipal Code. Entertainment Permits approved by the City shall be posted in a highly visible location on the premises where the permitted entertainment is conducted so as to be readily inspected by representatives of the City of Redondo Beach and the general public.

EXEMPTIONS FROM PERMITTING REQUIREMENT: An Entertainment Permit <u>shall not</u> be required for: City sponsored activities, church or religious activities, and private or public school activities, other than commercial events occurring on church or school property. In addition, an Entertainment Permit shall not be required where: only one individual at a time will be participating in the entertainment, the sound is not amplified in any way, sound from the location does not violate the City's Noise Ordinance standards, parking for the premises meets City Code requirements, and a current Business License exists for the location. Short term events of three (3) days or less for which a Temporary Use Permit is required pursuant to Title 10, Chapter 2, Section 10-2.2520 of the Redondo Beach Municipal Code are also exempt from the requirement for an Entertainment Permit.

PERMIT TYPES:

There are two (2) types of Entertainment Permits available pursuant to Title 4, Chapter 17 of the Redondo Beach Municipal Code.

LEVEL I PERMIT: A "Level I" Entertainment Permit shall be required where: the number of persons participating in the entertainment are one (1) to three (3), the sound is amplified and/or recorded, the parking for the premises meets all City Code requirements, and a current Business License exists for the location.

LEVEL II PERMIT: A "Level II" Entertainment Permit shall be required where: the entertainment provided does not qualify for issuance of a Level I Entertainment Permit, or where the Permit Administrator has declined to process an application for a Level I Entertainment Permit as such.

INSTRUCTIONS FOR FILING:

APPLICATION FORM:

- 1. All Information in this application shall be typed or legibly printed.
- Give full and complete answers to all questions.
- 3. If necessary, attach extra sheets to answer questions fully.
- 4. Applications are completed under penalty of perjury under the laws of the State of California.

APPLICATION FEE:

- 1. At the time of filing an application for an Entertainment Permit with the Planning Department, the required permit fee shall be paid (cash or check).
- 2. Checks shall be made payable to: City of Redondo Beach

APPLICATION FOR ENTERTAINMENT PERMIT

PROCEDURE FOR PROCESSING APPLICATIONS:

Upon receipt of completed applications for an Entertainment Permit, the Permit Administrator shall refer the application to the Chief of Police and Division Fire Chief for investigation, report and recommendation.

LEVEL I ENTERTAINMENT PERMITS: Decisions regarding applications for a Level I Entertainment Permit are made by the Permit Administrator. A public hearing <u>is not</u> required prior to a decision. At least five (5) days prior to issuing his/her decision regarding an application for a Level I Entertainment Permit, the premises upon which the entertainment activity is to occur shall be posted with a notice of the pending Entertainment Permit application. In approving a request for a Level I Entertainment Permit, the Permit Administrator may attach any conditions he/she deems appropriate to protect the health, safety, and welfare of the community and the peaceful enjoyment of all adjacent properties.

The Permit Administrator may deny an application for a Level I Entertainment Permit if it is determined that the proposed entertainment may interfere with the quiet enjoyment of neighboring properties and that there are no conditions which may be attached to an approval of the permit which would adequately ameliorate these impacts. Additionally, the Permit Administrator may decline to process an application for a Level I Entertainment Permit. Such permits shall be processed as a Level II Entertainment Permit.

APPEAL OF DECISIONS MADE BY PERMIT ADMINISTRATOR: The grant or denial of an Entertainment Permit by the Permit Administrator may be appealed to the City Manager or his/her designee. A written notice of appeal must be filed with the City Clerk within five (5) days of the date of the decision by the Permit Administrator. No notice of appeal will be deemed filed unless accompanied by the appropriate appeal fee. As soon thereafter as is reasonable possible, an administrative hearing on the appeal shall be held by the City Manager or his/her designee, pursuant to Section 10-1.2506(f)(1-3), Title 10, Chapter 2 of the Redondo Beach Municipal Code. The decision of the City Manager or his/her designee regarding the appeal shall be final.

The City Council may, by majority vote, prior to any hearing on an appeal, pre-empt the jurisdiction of the City Manager to hear the appeal and accept jurisdiction over the appeal. Such an action shall not be considered as a pre-disposition on the part of the Council majority to favor or disfavor the merits of the appeal, but a recognition that the subject matter of the appeal has sufficient importance to the community to justify the attention of governing body. Notice and hearing regarding an appeal before the City Council shall be as required by Section 10-2.2506(f)(1-3), Title 10, Chapter 2 of the Redondo Beach Municipal Code.

LEVEL II ENTERTAINMENT PERMITS: Decisions regarding applications for Level II Entertainment Permits are made by the Redondo Beach City Council, following a duly noticed public hearing, pursuant to Section 10-2.2506(f)(1-3) of Title 10, Chapter 2 of the Redondo Beach Municipal Code. After such hearing, the City Council may grant the permit subject to such conditions as it shall deem necessary to protect the health, safety, and welfare of the community, and the peaceful enjoyment of all adjacent properties.

The City Council may deny any Entertainment Permit application if it determines that the proposed entertainment may interfere with the quiet enjoyment of neighboring properties, and there are no conditions which may be attached to an approval which would adequately ameliorate these impacts.

TERM OF ENTERTAINMENT PERMITS:

LEVEL I ENTERTAINMENT PERMITS: Level I Entertainment Permit may be granted for a period of one (1) year from the date of issuance and can be renewed on the anniversary date thereof unless revoked or suspended pursuant to Section 4-17.07 of Title 4, Chapter 17 of the Redondo Beach Municipal Code.

LEVEL II ENTERTAINMENT PERMITS: Level II Entertainment Permits may be granted by the City Council for a term of up to, but not to exceed, two (2) years from the date of issuance. Existing Level II Entertainment Permits may be renewed by the Permit Administrator without a public hearing if no condition of the permit has been violated, and if less than three formal (written) complaints have been made to the City concerning the permitted activity during the previous twelve (12) month period.

SECURITY BOND REQUIRED FOR ALL LEVEL I AND LEVEL II ENTERTAINMENT PERMITS:

Every Entertainment Permit issued pursuant to Title 4, Chapter 17 of the Redondo Beach Municipal Code shall require a security bond to be posted with the City to cover extraordinary law enforcement or public safety services provided to the permit holder resulting from the entertainment activity for which the permit is granted. The bond shall consist of cash deposited with the City in a specified amount which shall be returned to the permittee upon termination of the permit. The amount of the security bond for permitted entertainment activities shall be determined pursuant to schedule adopted by resolution of the Redondo Beach City Council.

The bond required may be drawn upon when, in the determination of the Chief of Police, "extraordinary law enforcement or public safety services" have been provided to the permittee in connection with the entertainment activity conducted under an approved Entertainment Permit. The amount drawn upon shall be determined by the Chief of Police, but shall not exceed the actual and reasonable cost of providing the extraordinary service. The Chief of Police shall notify the permittee in writing of any reduction in the bond, the reason therefore, the basis for calculating the amount of the reduction and the requirement that the bond be replenished. The permittee shall have five (5) days from the date of notification to replenish the bond in the amount specified. No entertainment may be conducted by the permittee after the five (5) day notice period has occurred until the bond has been replenished pursuant to the notice. Failure to replenish the bond within the five (5) day period shall result in automatic revocation of the permit with no further action by the City necessary.

APPLICATION FOR ENTERTAINMENT PERMIT

Within five (5) days of the notice to replenish and upon replenishment of the bond, the permittee may appeal the bond reduction and replenishment requirement to the City Manager by filing a written request for appeal with the City Manager within ten (10) days from the date of the written notice. The City Manager, or his/her designee, shall hold a hearing on the appeal, pursuant to Section 4-17.06(c) of Title 4, Chapter 17 of the Redondo Beach Municipal Code. The decision of the City Manager, or his/her designee, regarding the reduction of the bond, shall be final.

NATURE OF ENTERTAINMENT PERMITS:

Entertainment Permits issued pursuant to Title 4, Chapter 17 of the Redondo Beach Municipal Code are personal to the applicant, not to the premises upon which the permitted entertainment is conducted. Permits are not transferable or assignable. No other individual may conduct entertainment under the authority of a permit issued to another.

A permit shall not be deemed transferred or assigned if the permittee is a corporation or partnership which remains under the control of the same individual or individuals who controlled it at the time the permit was approved.

Approved Entertainment Permits are granted for the specific location for which the application was submitted. Any relocation of the permitted activity, or major alteration to the existing facility, shall require a new Entertainment Permit.





PRODUCER'S HISTORY

Shakespeare by the Sea (SBTS) is an established arts organization that has been operating in LA County since 1998 when it began producing a free Summer Shakespeare Festival that currently tours to over 15 communities and contemporary works in a fixed location indoor theatre.

In 2002, the company transformed an old city tow yard into an intimate 65 seat performance venue called **Little Fish Theatre (LFT)** to produce theatre year-round and is designated a Membership Company by Actor's Equity Association. While both programs provide impactful theater, LFT focuses on new and contemporary works that lend themselves to an intimate theatre venue. A LFT season includes over a dozen productions - full length plays, short form projects, and solo shows that include theatre artists from throughout the LA region.

In 2023, LFT produced 8 full run productions and 5 short run events for a total of 72 performances. LFT seasonally employed 63 professional actors and another 72 creative and technical personnel. There are 4 year-round employees.

Relocation - Last winter, after 21 years located in San Pedro, the organization lost the lease to the theatre venue to commercial re-development. The 2024 season (22nd year for LFT) was paused for a region-wide search to find a new venue. In March 2024, SBTS/LFT moved its entire operation Beach Cities Health District. Leaning on past experience transforming non-traditional spaces, we are currently Transforming the space into a professional theatre for LFT, with attached rehearsal hall, scenic shop, multiple dressing rooms, exhibit areas, and a large lobby and courtyard for entertaining. In Winter 24, LFT plans to resume productions and reopen to the public.

The new venue in Redondo Beach allows SBTS/LFT to continue its established entertainment programming for the public as well as expand into social and educational programing by engaging with some BCHD neighbors - allcove Beach Cities and their families and the residents, healthcare workers, and families of Silverado. This move is a new chapter, and an extension in our efforts to find ways to engage people who would not usually access theatre. With a 27th Season of Shakespeare on tour this summer and a full season planned at LFT in 2025, SBTS/LFT has renewed its mission to not only produce great plays but also make a positive impact in local community.

Leadership - SBTS/LFT Co-Artistic Directors Stephanie Coltrin and Suzanne Dean share over 40 years between them of experience in producing theater, developing new works, operating a venue, fundraising, theatre arts education and supporting creative and technical artists.

FIRST AMENDMET TO REAL ESTATE LEASE COMMERCIAL GROSS LEASE

THIS FIRST AMENDMENT TO LEASE ("Amendment") is dated __February 20__, 2024 (the "Amendment Date"), and entered into by and between Beach Cities Health District ("Lessor") and Shakespeare by the Sea d/b/a Little Fish Theatre, a California nonprofit public benefit corporation ("Lessee") (hereinafter referred as the "Parties" collectively or a "Party" individually).

BACKGROUND

- A. **WHEREAS**, Lessor and Lessee are parties to that certain Lease Agreement dated February 20, 2024 (the "Original Lease"),
- B. **WHEREAS**, Lessor is a Government Local District and operates a Community Wellness and Medical Office Building open to the public at 514 N. Prospect Ave., Redondo Beach, CA 90277.
- C. **WHEREAS**, Lessor and Lessee have agreed to establish the Lessee offices on the 3rd floor at 514 N. Prospect Ave., Redondo Beach, CA 90277.
- D. **WHEREAS**, The Lessee intends to apply for an entertainment permit with the City of Redondo Beach to have public performances in Suite L1 at 514 N. Prospect Ave., Redondo Beach, CA 90277.
- E. **WHEREAS**, The Lessor will allow the Lessee to use the District Suite L1 to prepare, stage-build, rehearse, etc. for public performances and any other related uses, for any other purposes consistent with the use made by other tenants in the Building, for any use permitted by law or for any other purpose for which Landlord gives its reasonable consent.

NOW THEREFORE, Lessor and Lessee, intending to be legally bound, agree to the following modifications to the Lease.

AGREEMENT


- 1. **Defined Terms**. All capitalized terms used herein but not specifically defined in this Amendment shall have the meanings ascribed to such terms in the original Lease.
- 2. **Recitals**. The recitals set forth above are hereby incorporated by reference and made a part of this Amendment.
- 3. **Premises. Paragraph 1.1** is changed to read:
 - The Premises consist of approximately 260 rentable square feet known as Suite 303 on the 3rd floor of the Building (as defined in Section 1.2 of "Original Lease"), which is further described on the floor plan attached hereto as Exhibit B (the "Premises"). The address of the Premises is 514 N. Prospect Avenue, Redondo Beach, CA 90277.
- 4. **Existing Lease; Entire Agreement.** Except as expressly modified by this Amendment, the terms and conditions of the Original Lease and Subsequent Addendums and Amendments, if any, remain unchanged and in full force and effect. The Lease, as modified by this Amendment, constitutes the entire agreement between Lessor and Lessee and supersedes all prior and contemporaneous agreements and understandings of Lessor and Lessee in connection therewith.
