J.1. RECEIVE AND FILE PRESENTATION FROM THE REDONDO BEACH POLICE DEPARTMENT REGARDING E-BIKE RESOURCES, SAFETY, AND BEST PRACTICES

Deputy Community Services Director Orta introduced the item; provided a brief background and deferred to Redondo Beach Police Officer Kyle Lofstrom, Community Based Officer, for a presentation.

Officer Lofstrom provided a presentation regarding E-bike resources, safety and best practices. He responded to questions from the Commission regarding what Commission Members can do to promote E-bike safety, implementing more bike lanes in the city, E-bike organizations, modeling good behavior, and being a confident leader.

Discussion followed regarding the importance of documenting/registering serial numbers.

Chairperson Reeds invited public comments.

Briana Egan, via Zoom, volunteer with various local bicycle advocacy organizations, thanked the Commission for its interest in bicycle and E-bike safety. She spoke about the city promoting education, enforcement, and engineering and the importance of upgrading bike lanes and separate infrastructure from car lanes. Additionally, she suggested the

Commission consider discussing added locations for bike lanes and protected bikes lanes in the City and request presentations from community organizations regarding the topic.

Deputy Community Services Director Orta reported receiving two eComments regarding this item which are posted on the City's website.

There were no other public comments.

Discussion followed regarding pros and cons of considering infrastructure, the importance of education, enforcement and accountability, focusing on high traffic areas and schools, working with Public Works to discuss additional protected lanes, and continuing the bike path to the high school. Ensuing discussion pertained to promoting E-bike safety on social media and in collaboration with RUTV.

Deputy Community Services Director Orta talked about inviting Public Works to a meeting to discuss opportunities for improved bicycle infrastructure. She urged the Commission to contact her with ideas.

Chairperson Reeds requested a copy of the Bicycle Master Plan for the Commission to review.

Motion by Commissioner Campisi, seconded by Commissioner Chabot, and approved by voice vote, to receive and file the report.

The motion carried, 10-0-5. Commissioners Cho, Edwards, Huynh, Taghvaei and Weiss were absent.

RECEIVE AND FILE PRESENTATION FROM THE PUBLIC WORKS DEPARTMENT REGARDING BIKES LANES INCLUDING USAGE, EFFECTIVENESS, AND IMPLEMENTATION PROCEDURES

BACKGROUND

In November 2025, the Youth Commission (Commission) identified electric bikes (E-bikes) as its main focus for 2026, specifically on their safe use, issues related to recent vandalism, rules and regulations, and best practices. At the Commission's special meeting on January 7, 2026, the Redondo Beach Police Department provided a presentation regarding E-bikes, including resources, safety, and best practices. As a continuation to this topic, the Commission requested staff return with an informational presentation regarding bike lanes as an additional safety measure for the use of E-bikes, including usage, effectiveness, and implementation procedures.

The Public Works Department will provide a presentation to the Commission to inform of the City's usage of bike lanes as well as information outlining the process for implementing additional bike lanes, where possible.

Staff recommends the Commission receive and file the presentation and provide input to staff if additional information or resources would be helpful to the Commission as it continues its focus on E-bike usage throughout the city.

RECEIVE AND FILE PRESENTATION FROM THE BEACH CITIES TRANSIT TEAM REGARDING TRANSIT SERVICES AND YOUTH RIDERSHIP

BACKGROUND

The Transit Division of the Community Services Department oversees the South Bay cities transit program, Beach Cities Transit (BCT), including services that run through Redondo Beach, Hermosa Beach, Manhattan Beach, and El Segundo. Staff from the Transit Division will provide an overview of current public transportation services available to residents, with a focus on fixed-route services. The presentation will highlight notable destinations and corridors currently served by BCT routes, including areas commonly accessed by youth for school, recreation, and community activities. BCT staff will also seek input from Commissioners regarding potential service gaps, unserved or underserved areas, and opportunities for improvements that could enhance accessibility and increase youth ridership. This discussion will help inform future service planning and ensure transit options better align with the mobility needs of Redondo Beach youth.

Staff recommends the Commission receive and file the presentation and provide input on additional improvements or program enhancements for Beach Cities Transit.
