

RESOLUTION NO. CC-2605-028

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A 2025-2026 FISCAL YEAR BUDGET MODIFICATION APPROPRIATING \$25,000 IN GRANT FUNDS FROM THE CALIFORNIA DEPARTMENT OF PARKS AND RECREATION DIVISION OF BOATING AND WATERWAYS, GRANT NUMBER C25S0607 TO THE CITY'S WATERFRONT & ECONOMIC DEVELOPMENT DEPARTMENT BUDGET FOR THE DISPOSAL OF ABANDONED OR SURRENDERED VESSELS IN KING HARBOR

WHEREAS, it is the intention of the City Council of the City of Redondo Beach ("City Council") to review the adopted budget from time to time; and

WHEREAS, in 2025 the City of Redondo Beach ("City") was awarded \$50,000 in grant funding from the California Department of Parks and Recreation Division of Boating and Waterways ("DBW") under the FY 2025/26 Surrendered and Abandoned Vessel Exchange (SAVE-25) Grant Agreement, Grant No. C25S0607 to assist in the disposal of abandoned or surrendered vessels; and

WHEREAS, in April 2026 the City of Redondo Beach ("City") was awarded an additional \$25,000 in grant funding from the California Department of Parks and Recreation Division of Boating and Waterways ("DBW") under the FY 2025/26 Surrendered and Abandoned Vessel Exchange (SAVE-25) Grant Agreement, Grant No. C25S0607 to assist in the disposal of abandoned or surrendered vessels; and

WHEREAS, the purpose of these grant funds is to reimburse the City for the costs of disposing surrendered and abandoned vessels within King Harbor; and

WHEREAS, the City's adopted budget needs to be modified to appropriate funds from outside sources for proposed expenditures; and

WHEREAS, the City's Waterfront & Economic Development Department will manage these grant funds and oversee the projects funded through the DBW.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That conditions have arisen during the 2025-2026 budget year that require budget modifications and, upon recommendation of the City Manager, the budget as adopted for Fiscal Year 2025-2026 is modified as follows:

Twenty five thousand dollars (\$25,000) from the California Department Parks and Recreation, Division of Boating and Waterways, Grant No. C25S0607 shall be appropriated to the City's Waterfront & Economic Development Department in the Intergovernmental Grants Fund.

SECTION 2. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed and instructed to correct the budget records of said City for Fiscal Year 2025-2026 in accordance with the above modification.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution, shall enter the same in the Book of Original Resolutions.
