

# **Overall Sentiment**







To avoid the impression of Quid pro quo please vote against this agreement. I am sure there are many other law firms who can provide legal services.



SB 79 is a transit-oriented development bill which would streamline production of housing within a half-mile of transit. This applies only to passenger rail, light rail, and BRT stops. So in Redondo it would apply only to the light rail station in North Redondo (Marine), and in the future to the RBTC/Galleria/K Line station with the planned extension. These are both areas already identified by the city as Housing Element opportunity sites for multifamily housing. Transit-oriented development is something the city supports, and SB 79 will reduce barriers to getting such projects approved and built. Streamlining brings benefits to residents by lowering the overall cost to build housing projects (less uncertainty, fees, time, parking requirements) and thus lowering rents on new units. We

see this in numerous places throughout the county that have built transit-oriented housing, including in Koreatown, where new transit-oriented apartments have stabilized and lowered rents.

As demonstrated in the city's CDBG report tonight (Item L.1), the need for housing in the city is significant. The report finds that of the 435 households receiving Section 8 vouchers, 76% are headed by elderly individuals. It also finds a majority of low-income renters are cost-burdened (spend >30% of income on rent). 14% of all households in the city are severely cost-burdened (spend >50% of income on housing costs). Median home sale price has increased by 12% to \$1.6 million since last year. The report states the city's goals are to increase the supply of affordable housing and fair housing. TOD and SB 79 will help the city achieve this. Many older and low-income residents prefer to live near transit, in addition to younger car-lite folks, and we should embrace opportunities to build more housing near transit.

Furthermore, the bill will open up housing opportunity in El Segundo along their light rail stations, where notably the city of El Segundo has not previously allowed for housing. I've heard Mayor Light advocate for housing east of PCH in El Segundo to alleviate housing burden on cities like Redondo, so I hope he would support or at least remain neutral on this bill for that purpose.

Abundant Housing LA would like to express our strong opposition to item H.17, a letter to oppose SB 79 (Wiener). SB 79 will allow much-needed housing development near transit stops. By doing so, SB 79 will help address the state's housing shortage while promoting sustainable development, reducing traffic congestion, and supporting public transit systems.

Abundant Housing LA is a non-profit organization dedicated to advocating for more housing at all levels of affordability throughout LA County. Our vision is a Los Angeles where every resident can afford a home, in the neighborhood of their choice, without the need to rely on a car. Our message is simple: for too long cities across LA County have made it illegal to build the housing we need through apartment bans and low-density zoning restrictions.

These low-density zoning restrictions have not only directly contributed to our housing crisis, but have also led to urban sprawl which has in turn led to traffic congestion, air pollution, and carbon emissions which have degraded our climate. If we hope to bring down the cost of housing, and get people out of their cars in order to reduce traffic and mitigate climate change, we must build more housing near transit.

Further, LA Metro is in the process of a major expansion of rail transit. As residents of LA County, we are all investing in this expansion through our taxes, and it is imperative that we ensure the long term success of this investment. Transit systems rely on reliable ridership in order to succeed, and a significant source of the ridership comes from the residents of transit-adjacent buildings.

SB 79 will both respond to our housing crisis by facilitating more housing development, and ensure the long term success of our transit investments by allowing transit riders to live near stations. We hope that you will not only

oppose this resolution, but that you will support SB 79 as a critical tool to build the housing we desperately need near the transit infrastructure that we are all investing in.

Metro does not own land by the existing Redondo Beach station on Marine.


They lease the land for the parking lot from SCE. Therefore, the only housing that can be developed there will be consistent with his own Tech Area Housing Overlay.



The report finds that of the 435 households receiving Section 8 vouchers, 76% are headed by elderly individuals. It also finds a majority of low-income renters are cost-burdened (spend >30% of income on rent). And 14% of households in the city are severely cost-burdened (spend >50% of income on housing costs). Median home sale price has increased by 12% to \$1.6 million since last year. These statistics support a clear need for housing of all types in the city -- senior housing, affordable housing, and market-rate housing.

I also support the goals identified in this plan, including: Support Development of Decent and Affordable Housing, Provide Services for the Vulnerable Population, Support New Affordable Housing, Provide Housing and Supportive Services for People Experiencing Homelessness, Support Fair Housing Activities. I commend the city for its progress on providing supportive housing and services for homeless individuals. And I hope to see the city council and Planning Commission support new housing projects that come before it, including transit-oriented and affordable projects. The project approved in January on the corner of PCH and Vincent is a good example of infill housing that provides a variety of housing types (affordable and market-rate) to advance the city's goals. I would like to note consistent with pg 91, that the city explores preserving affordable housing at Seasons and Seaside Villa to preserve affordable units for seniors.

I applaud the city's effort to not only limit the number of new smoke shops in Redondo Beach but also their efforts to regulate existing and new smoke shops. These actions have the potential to greatly impact youth health and safety in a positive way.

I suggest the following additions to this draft ordinance; specifically, include Non-Tobacco Nicotine Products (NTN) in this ordinance. In 2022, Congress gave the FDA the authority to regulate these products in the same manner as tobacco-derived products and synthetic and non-tobacco-derived nicotine products exist due to regulatory loopholes exploited by tobacco companies. The manufacturers of these products use marketing specifically targeted to youth, suggesting that these products are safe, healthy, nonaddictive and do not contain nicotine, leading to a rapid, ongoing increase in youth use and addiction. An estimated 42% of youth cannot correctly identify the source of nicotine, interpret 'tobacco-free nicotine" or understand nicotine concentration language. These are the products currently sold in legal smoke shops and the only way to protect our youth from these products is to remove them from the shelves, city by city.

Finally, I urge staff and city council to support language that makes this ordinance specific to ALL psychoactive hemp products. The peer-review literature supports that even products deemed "non psychoactive" upon laboratory testing, include intoxicating hemp.

I applaud efforts to limit additional smoke shops and to robustly enforce existing state laws.



Thank you to RBPD and city council for following up on e-bike use and safety in the city. I appreciate RBPD's outreach and engagement activities, including the bike rodeo events to teach safe riding to kids. Thanks to city and departmental leadership, I think we are striking the right balance between education, enforcement, and engineering.

I am grateful for the city's progress on engineering for e-bike safety, including the recent implementation of painted Class II bike lanes on Manhattan Beach Blvd, Catalina Ave, Torrance Blvd, and Knob Hill Ave which make biking along these routes much safer. I also strongly support the projects in the pipeline to build protected Class IV bike lanes on Prospect Blvd, Ripley, Grant, and Redondo Beach Blvd. I'm proud to see the city leading the way on high-quality bike infrastructure in the South Bay and I hope other cities follow suit. Biking for transportation reduces car traffic and fits well with our beach climate and lifestyle.

Finally, I encourage the city to advance additional Class IV protected bike lanes in the city for a complete network. I hope the council can champion the proposal for a corridor study of protected bike lanes on Prospect Ave, which would connect 11 schools and 7,000 students with safer routes to school. I also encourage the city to partner with community partners like SBBC+ and South Bay Forward on bicycle education and community quick-build bike infrastructure projects. Thank you!

I encourage the council to focus not only on enforcement and education solutions to issues raised by e-bikes, but on engineering solutions to make e-biking safer to begin with. In particular, the council should fund the class IV lane on Palos Verdes Blvd which has already been recommended by the public works commission, and the council should adopt SBBC+'s proposal of a protected class IV lane along Prospect Blvd. to provide students and families safe bike access to schools along that corridor.
