

**RESOLUTION NO. CC-2010-070**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A 2020-2021 FISCAL YEAR BUDGET MODIFICATION TO APPROPRIATE TWENTY ONE THOUSAND FIVE HUNDRED DOLLARS (\$21,500) IN AVAILABLE SUBDIVISION PARK TRUST FUNDS TO THE BICYCLE TRANSPORTATION PLAN IMPLEMENTATION PROJECT, JOB NO. 40510**

WHEREAS, it is the intention of the City Council of the City of Redondo Beach ("City") to review the adopted budget from time to time; and

WHEREAS, the City's adopted budget needs to be modified to appropriate monies from available fund balances for necessary expenditures; and

WHEREAS, on June 19, 2018, the City Council approved the Bicycle Transportation Plan Implementation Project, Job No. 40510 ("the Project") as part of the 2018-2019 fiscal year budget authorization; and

WHEREAS, on January, 22, 2019, the City Council approved allocating funding from the Project for design services to extend the North Redondo Beach Bikeway from Felton Lane to Inglewood Avenue; and

WHEREAS, on August 27, 2020, the Los Angeles County Metropolitan Transportation Authority Board ("Metro") approved construction funding for an extension of the North Redondo Beach Bikeway from Felton Lane to Inglewood Avenue in the amount of \$1,000,000 to be disbursed over FY 2020-2021 and FY 2021-2022; and

WHEREAS, the construction funding granted by Metro allows for enhancements to landscaping and irrigation construction beyond the original design of the Project; and

WHEREAS, there is insufficient funding to complete these design enhancements; and

WHEREAS, there are unencumbered funds in the Subdivision Park Trust (Quimby) Fund available for appropriation; and

WHEREAS, the City desires to appropriate \$21,500 from the Subdivision Park Trust (Quimby) Fund to the Project to complete the design enhancements.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** That the amounts allocated in the budget for Fiscal Year 2020-2021 and the amounts required to meet conditions which have arisen during the budget year, require a modification in the budget appropriations; and, upon recommendation of the City Manager, the budget appropriation as adopted for Fiscal Year 2020-2021 is modified as follows:

Twenty-one thousand five hundred dollars (\$21,500) from the Subdivision Park Trust Fund shall be appropriated to the Bicycle Transportation Plan Implementation Project, Job No. 40510 .

SECTION 2. That pursuant to Section 11(f) of the City Charter, the City Clerk of said City is hereby directed to correct the budget record of said City for Fiscal Year 2020-2021 in accordance with the above modifications.

SECTION 3: This Resolution shall take effect immediately upon its adoption by the City Council.

SECTION 4: The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
