Throughout BCHD's sales pitch to District taxpayers about the non-resident Healthy Living Campus, the 100% private developer was always paying for the demolition of the hospital and fixing the mess that would be left afterwards. Always. No other deal was ever presented to District taxpayers.

It appears that BCHD has elected to put a \$30M property tax bond on the November 2024 ballot based on the vote from the Board Members at the July 24, 2024 BCHD BoD meeting. The \$30M's use has been changed by BCHD several times, but is currently:

**allcove is not a District Program.** Allcove is an LA County Health Department Service Planning Area 8 (1.4M population) program. BCHD volunteered to service the entire area **for 30 years** (building and program operation required). BCHD has no operational funding beyond June 2026. The 30 year liability to District Taxpayers was not computed by BCHD prior to accepting the cost liability, but it is approx. **\$175M based on credible calculations.**

BCHD's **100% private Developer** of the proposed 80% non-resident assisted living facility **committed** in its proposal to conduct Demolition and Open Space **WITH NO COST TO TAXPAYERS**

**This is a \$15M "in kind" payment by BCHD to the Developer w/ Bond Funds**

This \$6M is in addition to the \$14M in Taxpayer funding BCHD has already spent on consultants for the **80% to 95% non-resident Healthy Living Campus**

In addition, BCHD has a misleading narrative for the bond measure. A few additional factual items are required and added in red:

Last, BCHD's case in favor of its bond contains significant omissions:

<p><b>Argument in Favor of Measure [X]</b></p> <p><b>Measure [X]: IMPROVE COMMUNITY HEALTH:</b> The Surgeon General calls youth mental health an "urgent public health crisis." In our community, 1 in 12 eleventh graders have reported seriously considering attempting suicide; 1 in 5 youth will have a mental health challenge in their lifetime.</p> <p>To address youth mental health and provide needed services, Beach Cities Health District brought allcove to the Beach Cities—the region's only comprehensive wellness center focused on mental health for ages 12-25. allcove provides mental health, physical health, substance use, peer support, family support and education/employment services. There have been 8,000+ visits to allcove's temporary location, with 74% of those receiving service from the Beach Cities/Torrance.</p> <p>The Beach Cities Health District Community Health and Wellness measure will provide funding necessary to complete construction of the permanent allcove center, including upgraded energy-efficient systems, electric vehicle/bike parking, solar and other sustainable materials.</p> <p><b>HEALTH &amp; OPEN SPACE:</b> In addition to building the new allcove facility, the measure will fund approximately 2 acres of outdoor open/wellness space limited to supporting health programs for youth/adults/older adults, a community garden, walking trails, and fitness classes for the Center for Health &amp; Fitness and the community.</p> <p>The open space will replace the deteriorating South Bay Hospital building that doesn't meet current seismic building standards, lowering risk of earthquake damage—saving lives.</p> <p>Measure [X] funds the allcove building, open space and demolition, allowing BCHD to continue providing 40+ health services, like social workers supporting older adults, in-school health programs and healthy activities for our community.</p> <p><b>STRICT ACCOUNTABILITY/TRANSPARENCY:</b> A citizens' oversight committee will ensure funding meets financial accountability requirements.</p> <p>This is a high-impact, low-cost measure. Homeowners with an assessed value of \$1,000,000 would pay about \$2.50/month to maintain BCHD's community health services.</p>	<p><b>DISTRICT TAXPAYERS AND VOTERS DESERVE THE FULL STORY!</b></p> <p>allcove is a 91% non-resident SPA8 service area with no funding other than District Taxpayers beyond June 2026.</p> <p>BCHD asserted it would service a 1.4M population area with allcove. Instead, BCHD has concentrated 70% of the funding on the District and Torrance. This discriminates against disadvantaged communities and areas of mental health provider shortages in the allcove Service Area.</p> <p>BCHD's implementation of allcove also discriminates against the non-White, lower income communities that it pledged to service in its State of California application.</p> <p>No building that is not built in the current period meeting current seismic regulations. Nor must it. Nor must homes. BCHD's Youssef consultants noted that best practice allows 25 more years of use of the Hospital that BCHD falsely characterizes as a MUST DEMOLISH.</p>

Public Comment All Agencies:

Because Beach Cities Health District (BCHD) is accepting funding from the Mental Health Services Act (MHSA) on behalf of all of LA County Health SPA8, the SPA8 cities that are Mental Healthcare Worker Shortage Areas and Disadvantaged Communities must advocate for themselves to the MHSA Oversight Advisory Committee (MHSOAC) at [MHSOAC@mhsaac.ca.gov](mailto:MHSOAC@mhsaac.ca.gov) and the senior most executives in charge of the MHSA funding at [Mark.Ghaly@chhs.ca.gov](mailto:Mark.Ghaly@chhs.ca.gov), [jared.goldman@chhs.ca.gov](mailto:jared.goldman@chhs.ca.gov), and [Toby.Ewing@mhsaac.ca.gov](mailto:Toby.Ewing@mhsaac.ca.gov).

It is unconscionable that BCHD is spending 50% of SPA8 allcove resources on relatively affluent Redondo Beach, Hermosa Beach and Manhattan Beach areas when so many disadvantaged areas exist in SPA8. Furthermore, BCHD is spending over 70% of allcove resources on those three cities plus Torrance, depriving the other 91% of SPA8 population from adequate allcove services.

Also, BCHD is planning to build the allcove facility in Redondo Beach, roughly a mile from the ocean. That location is highly inaccessible to the most disadvantaged, healthcare provider short, non-white, lower income SPA8 cities.

We encourage the cities listed below with higher non-white populations, lower incomes, and official designations are MSHA and Disadvantaged Communities to weigh in and preserve their rights. BCHD is obligated by state contract to provide allcove building and services for 30 years - and the longer the overwhelming majority of SPA8 is excluded, the more likely that BCHD will deny them allcove services.

On Tue, Jul 23, 2024 at 12:07 PM Stop BCHD [REDACTED] wrote:  
 Over 80% of allcove BCHDs participants are from RB/HB/MB/Torrance/"Other" - while Disadvantaged Communities and Mental Health Professional Shortage Areas get less than 15% of allcove services. THAT'S UNFAIR. THAT'S ALSO A POTENTIAL LIABILITY TO BCHD Taxpayers if the State audits BCHD and claws back the funding. While we can never know the intent of BCHDs Board's expansion into 80% to 95% non-resident services - we can surmise that BCHD expanded its allcove service area to win a funding award. BCHD added 1.2M population to the Health District for allcove, apparently in order to secure some Disadvantaged Communities, Lower Income Areas, Non-white Areas, and Mental Health Professional Shortage Areas (MHPASAs) and score more points on the funding evaluation. BUT WHEN THE RESULTS ARE IN - BCHD SPENT THE FUNDING ON RELATIVELY HIGH INCOME, RELATIVELY WHITE AREAS WITH AMPLE MENTAL HEALTH PROFESSIONALS. MHPASAs and Disadvantaged communities carried the day for BCHD's funding request - yet - BCHDs threw them crumbs. The BCHD Board has failed and opened District taxpayers to financial liability.

In order to have a more “attractive” application for MHSA funding, BCHD appears to have expanded its service area from the relatively white and affluent voter-approved “residents who reside within the District” to all of LA County Health’s Service Planning Area #8.

That neatly checked the mental health professional shortage areas (MHSAs), disadvantaged communities, populations with racial disparities, and ethnically diverse groups for the purpose of evaluation of funding applications.

Unfortunately as the analysis shows, over 70% of allcove participation is from Redondo, Hermosa, Manhattan, and Torrance – while the disadvantaged communities and MHSAs are catching the crumbs of BCHDs program, participation, and spending.



5. Grant awards will be calculated based on multiple factors, including but not limited to: number of total applications received, number of applications received by track and practice model type, and, number of total individuals expected to be impacted (i.e., served) by grant applicant as a result of the grant award. Priority will be given to applicants serving communities with higher demonstrated need (e.g., mental health professional shortage areas, socio-economically disadvantaged communities, communities with populations of focus) or those which propose to reduce disparities between racial/ethnic/marginalized groups in the community.
