Amended Terms: Unless specified otherwise, this Modification is effective as of the date the last party signs this Modification. This is a Modification to the Peregrine Customer Order Form & Scope of Services (the “Agreement”) dated July 9, 2024, originally executed by and between Peregrine and Customer. Unless otherwise defined in this Modification, all capitalized terms used in this Modification will have the definitions ascribed to them in the Agreement. The parties agree as follows: Professional Services: The Customer Data sources and systems that Peregrine will integrate with the Service for Customer are hereby changed from: Mark43 CAD, Mark43 RMS, Axon Evidence.com, Vigilant LPR (30-day retention), Flock LPR (30-day retention), LaserFiche. To: Mark43 CAD, Mark43 RMS, Axon Evidence.com, Vigilant LPR (30-day retention), Flock LPR (30-day retention), LaserFiche, and TurboData. By addition of: TurboData Service Fee. The Parties further agree that the additional integrations prescribed above shall modify the fee schedule. The Fee Schedule is modified from: b. \$96,500 within 45 days of July 10, 2026 To: b. \$103,900 within 45 days of August 18, 2026 By addition of \$7,400 for the TurboData integration.

For avoidance of doubt, Customer has already been invoiced for the original fee of \$96,500 in accordance with the Agreement. As a result of this Modification, Customer shall pay the additional \$7,400 for the TurboData integration within 45 days of the Effective Date of this Modification.

Miscellaneous:

Entire Agreement. Except as modified by this Modification, the Agreement shall remain in full force and effect. This Modification, together with the Agreement as amended by this Modification, supersedes all prior and contemporaneous agreements between the parties with respect to the services hereof. In the event of a conflict between this Modification and the Agreement, the terms of this Modification shall control.

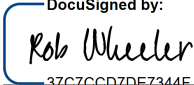
Warranties. Each party represents and warrants that it has the legal power and authority to enter this Modification.
