C. SALUTE TO THE FLAG AND INVOCATION

Mayor Light invited veterans and active-duty military to stand and be recognized for their service.

Councilmember Kaluderovic led in the Salute to the Flag.

Mayor Light asked all to remain standing for a moment of silent invocation.

D. PRESENTATIONS/PROCLAMATIONS/ANNOUNCEMENTS/AB 1234 TRAVEL

Mayor Light announced he had one presentation that evening; asked Councilmember Castle to join him in honoring Dr. Martin Luther King Jr.; spoke about Dr. King's legacy and his impact on the nation; stated Redondo Beach values diversity, inclusion, and civic responsibility and that evening they reaffirm the City's commitment to Dr. King's legacy and reflect on his message; proclaimed, on behalf of the City Council and as Mayor, Monday, January 19th, 2026 as Martin Luther King Jr. Day in the City of Redondo Beach and had Councilmember Castle accept the proclamation on behalf of the City.

Mayor Light reported attending the Blood Drive hosted by the RBPD and the Cal Cities' LA County Division Meeting the previous week; hosted Mayor Bash who visited Redondo Beach on Saturday; met with Citizens for Redondo Trees and participated in planting over 850 native plants in the new lower pond at Wilderness Park on Sunday with over 100 RUHS students; acknowledged Geraldine Trivedi (Public Works) for all her work as the lead engineer for that project; announced there was a meeting earlier that day regarding water polo and events for that summer; met with members of the Public Amenities Commission.

Councilmember Waller congratulated Officer Lofstrom on a successful Blood Drive that received 103 donations; announced he would have a meeting later that week on the status of the Avenue A pedestrian ramp and a Clean Power Alliance Board of Directors meeting; announced the NRBBA's mixer at Trusted Gut from 5:30 p.m. to 8:00 p.m. on January 14th.

Councilmember Castle reported attending the Cal Cities' dinner last week and speaking to the state Senator and other dignitaries from Sacramento; attended the King Harbor Association Board Meeting on Wednesday morning and received a lot of feedback from the boat parade; announced he would attend the Martin Luther King Day celebration at the California Surf Club where Goodie Goodloe would be speaking and, on Saturday, would attend the In and Out Car Show and stated it would be coming to Seaside Lagoon.

Councilmember Kaluderovic reported donating blood at the RBPD Blood Drive; attended

the Cal Cities' LA Division General Meeting, a meeting at the LA Air Force Base with the Governor's Military Council and Director Myers from the Governor's Office of Business and Economic Development to discuss the importance of the base, aerospace industry, and space force; announced she and Councilmember Obagi would be co-hosting a Community Meeting on January 24th at 9:00 a.m. at the North Branch Library with speaker Tom Bakaly; reported that on January 22nd the Metro Board will be deciding where to build the Green Line extension to Torrance and stated they are chartering a bus to help residents get to the meeting and advocate for the best option, Hawthorne Blvd; noted that the bus will be at the Redondo Beach Transit Center and will leave promptly at 7:20 a.m.

Councilmember Obagi reported donating blood at the RBPB Blood Drive and thanked Officer Lofstrom for running the event; echoed Councilmember Kaluderovic's announcements regarding the combined Community Meeting on January 24th and regarding the Metro Board Meeting and encouraged all Redondo residents to attend; stated the dangers of having two additional Metro tracks that will have hundreds of trains every day over seven fuel and gas pipelines next to a freight train carrying combustible materials is no place to build a new rail system; commented that the K Line is elevated throughout El Segundo so why shouldn't it remain elevated when it gets to Lawndale and Redondo Beach; announced a planning and programming meeting at Metro headquarters for January 14th at 11:00 a.m.

Mayor Light invited public comments.

Dr. Andy Lesser spoke on item H.4; stated he is the President of Southern California Labrador Retriever Rescue and reported that the City of Torrance uses DocuPet as their pet licensing vendor; stated that Torrance and DocuPet approved a large donation to his non-profit Labrador Retriever Rescue; referred DocuPet as a potential vendor for Redondo Beach.

Laura Diaz reported no hands raised on Zoom and no eComments.

Councilmember Obagi thanked Public Works for H.5 and for prioritizing residential rehab.

Motion carried 5-0 by voice vote.

J. PUBLIC PARTICIPATION ON NON-AGENDA ITEMS

J.1. For eComments and Emails Received from the Public

Keli Williams, 30-year resident, spoke about the state of the post office near Catalina and Gertruda; noted that there are weeds all over the United States Postal Service sign and that the property looks neglected; reported that, over the last five years, she has repeatedly reached out to the postmaster and was informed that there is no budget for landscaping due to covid; commented that other maintenance and upgrades have been made to that location but the trees are growing all over the property; encouraged everyone to drive by and see what she is referring to; asked that the City send the post office a code violation letter.

Councilmember Castle noted that the post office she is referring to is in District 2 and he has received several phone calls from residents regarding the state of it; reported visiting the location and trying to meet with the manager, he has also reached out to other politicians to see if they can get some help; appreciated her bringing it to their attention.

Mayor Light reported he has tried several times to call the postmaster, but no one answers and it doesn't go to voicemail; noted that he has asked code enforcement to look into it.

Councilmember Obagi mentioned he has contacted Ted Lieu about it as well.

Georgette Gantner, District 2, stated that she finally read the entire AACAP and didn't realize the amount of money and effort that has been put into the plan; spoke about the vacancies and non-operating businesses around the City and asked if any PR is being done to educate everyone including neighboring cities about the huge effort that is being made to revitalize the Artesia/Aviation corridor; noted that the City is losing money on the vacant and non-operating businesses and wondered if these property owners knew how much effort was being put into the area that they may sell and the area will begin to look better immediately.

Jim Mueller spoke about government needing to be transparent about its condition and problems they face and provide the opportunity to give input and feedback from their citizens; noted some issues he has found while trying to be a good citizen: 1) financial transparency reports have been taken down from the Finance Department website, 2) the shutdown of the Public Safety Commission which is now under Public Works but they never seem to discuss safety issues related to law enforcement, 3) the Finance Director responds to Budget and Finance Commissioners' questions by justifying the status quo, complaining about staffing, and when she provides data it is often incomplete or inaccurate, 4) removing the CUP process for key development projects on Artesia which eliminates a layer of public review and comment, 5) quarterly budget reporting doesn't conform to financial reporting conventions familiar to the public which creates a barrier to

public understanding of the City's financial performance, condition, and outlook, 6) high-value, sometimes multi-year consulting contracts, awarded with non-compete provisions in the municipal code, and automatic and/or Consent Calendar extensions; hoped more citizens take an interest in their City government and vote in the upcoming elections so the elected will have a better idea of how to keep Redondo an amazing place to live.

Maria Larissa Yasol asked everyone to go to Redondo Beach on their phones and stated that many of the City's businesses show up under no events or lack clear placement entirely and they should be showcased as part of a vibrant international destination; stated branding communicates priorities and signals value; noted that King Harbor and its businesses are defining civic assets yet their visibility is inconsistent; encouraged the Council to request a briefing to ensure the City's branding are clear, prominent, consistent and supports community pride, tourism, and long-term economic stewardship.

Gil Escontrias stated he is there in response to the Mayor's recent remarks on social media concerning a use of force incident involving a federal officer; spoke of the Mayor's right to speak as a private citizen but when he does identify himself as the Mayor he is then speaking as the City's chief elected official and his words need to reflect the position; reported he has 45 years of police experience but is speaking as a private citizen and stated he would be hesitant to offer public opinion based on a few seconds of video especially without a full investigation; stated that use of force in policing is dynamic and not scripted and can be difficult to watch but often necessary; noted that the encounters demand seriousness, restraint, and informed judgement and that is why the public comments made by the Mayor are deeply concerning; stated policing tactics are professional disciplines grounded in training, policy, and experience and when elected officials engage in amateur meddling of professional operations it exposes the City and pulls them into tactical debates that should never be politicized; stated that comments may harm the officers by making them hesitate in critical moments, question whether they have the support of City leadership, or whether their actions may be publicly undermined later; hoped that the position of the City Council would be to withhold judgement on any incident involving RBPd until all facts are fully investigated and to defend them; asked the City Attorney to review the policies and procedures concerning public comment by the members of the Council as well as the Mayor and how it affects the City on social media.

Laura Diaz reported no hands raised and no eComments.

Motion carried 5-0 by voice vote.

Jane Chung, Assistant to the City Manager, announced that she was joined by Senior Deputy City Prosecutor Stephanie Johnson; introduced the item and went over what they would be discussing in the presentation; explained that the Permanent Local Housing Allocation (PLHA) Program is also known as the Building Homes and Jobs Act and that it created a permanent statewide funding source for housing related needs and funds are generated through real estate transaction recording fees; reported that a jurisdiction must be a recipient of community development block grants or CDBG grants to qualify for PLHA Program funding and Redondo Beach does qualify; reported that, on October 15, 2024, the state released Notice of Funding Availability (NOFA) and Redondo Beach is eligible to receive up to \$198,126 of the approximately \$320 million available statewide for the 2022 and 2023 allocation years; noted that the 2024 NOFA represents the final allocation under the City's current five-year PLHA Program Plan; reported that this NOFA also reflects an adjustment to the City's total five-year allocation, the original estimate of

\$784,980 had been revised to \$756,188; stated that the City, to date, has received \$475,874.15 and they have a current available balance of \$280,313.85 for this application for the Council's consideration; turned the floor over to Stephanie Johnson.

Senior Deputy City Prosecutor Johnson stated the PLHA supports the City's current 20 pallet shelters on Kingsdale in Redondo Beach along with LA County and Harbor Interfaith; reported, to date, the PLHA has served 134 unhoused individuals and 78 have been permanently housed; stated that all 20 units are currently filled and five residents are matched with housing but waiting to either sign their lease or for housing inspections to be completed.

City Attorney Ford added that the finances are going to their operational cost and that is what they have traditionally used the funding for; reported that the City's agreement with the County, per the last amendment they made with the agreement, was for a six month period because they did not know what the 2024 and 2025 allocations would be; noted that the agreement with the County will expire on March 31st and they are looking for other sources to utilize to continue operations; stated that, historically, the annual budget is almost \$1 million and stated that the County pays for most of it and the City pays about \$26,000 per month; staff provided a slide with the current breakdown of costs: \$291,855.49 paid by the City, and \$642,399.80 paid by LA County.

Assistant to the City Manager Chung stated in order for a jurisdiction to receive its funding allocation it needs to meet several application requirements and provided the five requirements on the PowerPoint presentation; turned the floor back over to the City Attorney to explain the first requirement.

City Attorney Ford noted that on page 2 of the actual application, on Section 302 A, there is a question asking if a Housing Element was adopted by the local governments governing body and subsequently determined to be in substantial compliance with State Housing Element Law pursuant to the statute; confirmed that on the application the City is stating yes and they will add a note there that says pertaining to years 2022 and 2023.

Assistant to the City Manager Chung stated staff recommended that the City Council conduct the noticed Public Hearing that evening, adopt Resolution No. CC-2601-003, and approve the PLHA Program Plan application for the remaining 2021 to 2023 cycle.

Councilmember Behrendt asked the City Attorney, in the application, if the information and representations made in the PLHA Grant Application, along with what she mentioned she would add complete and accurate information in representations.

City Attorney Ford responded yes.

Motion by Councilmember Kaluderovic, seconded by Councilmember Castle, to adopt Resolution No. CC-2601-003, PLHA Program Plan for 2021 through 2023 allocations and approve the PLHA Program Plan Application with the additions stated.

Mayor Light invited public comments.

Laura Diaz reported no hands raised on Zoom and no eComments.

Motion carried 5-0 by voice vote.

Motion by Councilmember Kaluderovic, seconded by Councilmember Castle, to close the Public Hearing.

Motion carried 5-0 by voice vote.

Laura Diaz read L.1 adopt by title only Resolution No. CC-2601-003.

O. CITY MANAGER ITEMS

City Manager Witzansky reminded everyone that there is a City Council meeting next Tuesday, January 20th and they will be dark the fourth Tuesday of the month; announced Police Chief Sprengel will have his ceremonial swearing in at the start of the meeting on the 20th.

P. MAYOR AND COUNCIL ITEMS

P.1. DISCUSSION AND POSSIBLE ACTION RELATED TO THE CITY'S PROHIBITION OF GENERAL FOOD SALES, INCLUSIVE OF BEER AND WINE, AT SERVICE STATIONS IN THE COASTAL ZONE

Luke Smude, Assistant to the City Manager, reported that the item is being brought forth for Council discussion and consideration based on a November 4, 2025 referral from Councilmember Castle; stated that general food sales are general grocery items and that class of goods is inclusive of beer and wine, noted that that definition is put forth in the Business and Professions Code; clarified that when considering general food items they cannot legally exclude beer and wine but liquor is excluded; reported that prior to October of 2023, the City's 11 service stations were prohibited from selling general grocery items and that was due to an ordinance that was passed by the City in 1971; stated that the City Council elected to change that in October of 2023 by Ordinance 3263-23, which authorized general food sales at the City's service stations in the inland zone; stated that 9 of the 11 service stations are in the inland zone and if they were interested in selling general food they had to apply for a new or amend their existing CUP and adhere to state and local laws; noted that the Business and Professions Code regulates general food sales and has an extensive list of regulations plus local jurisdictions can add additional restrictions if desired; reported that, when Council elected to authorize general food sales in the inland zone, Council added additional City regulations which he described in more detail the additions and the intention for the added regulations; stated staff is bringing this

back for consideration at the request of Councilmember Castle and strictly for the Coastal Zone; noted that if Council chooses to take no action the prohibition of general food sales would remain intact in the Coastal Zone but, if they direct staff to prepare an ordinance to allow general food sales in the Coastal Zone, staff would work with the City Attorney's office to prepare an ordinance that mirrors the inland zone regulations and then bring it back in February for Council's consideration.

Mayor Light noted that if there is an ordinance change in the Coastal Zone the Coastal Commission will have to review it.

Discussion followed regarding how many they can do per year, what they have scheduled currently, and whether the limit pertains to LCP amendments only or if CDPs are included.

Councilmember Obagi highlighted the Mobil gas station at Inglewood and Artesia and noted the owner of the station had wanted to invest in the gas station and needed to be able to sell groceries which was why Council had brought the item forward for the non-Coastal Zone; spoke about the renovations made to that gas station and how well the owner has followed the regulations and restrictions; voiced his support for the item for the Coastal Zone.

Councilmember Waller opined that the Coastal Zone isn't different than the inland zone; noted it would only affect one location which lost the 7-Eleven franchise due to its inability to sell beer and wine; felt the location is a prime one and voiced his support for updating the City's ordinance.

Councilmember Castle reiterated the points Councilmember Waller made; noted that the current law had the opposite effect on the location in his district that had the 7-Eleven and felt supporting this item would help that owner get back the business he has lost.

Motion by Councilmember Castle, seconded by Councilmember Waller, to direct staff to come back with the necessary ordinance change to amend and make it congruent with the inland zone service stations.

Mayor Light invited public comments.

Sam Vartanian, owner of 76 Station at Torrance and PCH, stated 11 years ago, after completing a major remodeling of the property, they were excited for the opportunity to become a franchisee of 7-Eleven and, as part of the process, accepted two standard requirements of opening 24 hours a day and applying for a beer and wine license; stated they were unaware of the outdated and unreasonable provision of the municipal code that limits the gas station sales items to immediate consumption of motoring publics; provided some details on his attempts to have the provision removed so that he could operate as a normal functional C store; reported that former Councilmember Nils Nehrenheim, at that time, had good intentions to solve the homeless problem in Redondo Beach and blocked every attempt to remove the provision; reported that it was approved by Council to allow all gas stations on the east side of PCH but created another problem for those west of

PCH; the speaker ran out of time and was not able to continue.

Dr. Andy Lesser stated a few years ago he was against the general grocery along with beer and wine for the stations on the Coastal Zone but he has since changed his mind; spoke highly of the way Mr. Vartanian conducts his business and felt his ability to sell beer and wine would not have a negative impact on the neighborhood with the restrictions that Council has placed in the inland zone; stated it would be nice for the neighborhood to have groceries within walking distance and voiced his support for the item.

Marci Guillermo (via Zoom) opposed the item and stated for the record she doesn't feel it is appropriate.

Laura Diaz reported no one else online and no eComments.

Motion carried 5-0 by voice vote.

Q. MAYOR AND COUNCIL REFERRALS TO STAFF

Motion by Councilmember Obagi, seconded by Councilmember Kaluderovic, to have the City Attorney work with their Outside Legal Counsel to prepare a letter representing the City Council's viewpoint on the C-Line extension with Councilmember Behrendt abstaining including making reference to any decisions that are made at the Planning and Programming Committee.

City Manager Witzansky confirmed Councilmember Obagi's idea is to bring that letter back to the Council as part of an approval item next Tuesday for consideration, discussion, and possible action so it can be done in advance of the 27th.

Councilmember Obagi responded affirmatively.

Motion carried 4-0-1 by voice vote. Councilmember Behrendt abstained.

Councilmember Kaluderovic referenced discussions they have had regarding a maintenance standards ordinance and asked if staff had a timeline on that item.

City Manager Witzansky noted that Community Development Director Wiener is working on it but it will be several months before it is brought back.
