

**RESOLUTION NO. CC-2503-014**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL YEAR 2024-2025 BUDGET MODIFICATION TO REALLOCATE \$161,000 OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FROM THE MOBILITY, ACCESS, AND EMERGENCY REPAIR ACCOUNT; AND THE CITYWIDE CURB RAMP IMPROVEMENTS PROJECT, JOB NO. 40399, IN THE AMOUNT OF \$16,859 AND \$144,141, RESPECTIVELY.**

WHEREAS, it is the intention of the City Council of the City of Redondo Beach (“City Council”) to review the adopted budget from time to time; and

WHEREAS, the City of Redondo Beach’s (“City”) adopted budget needs to be modified to reallocate and appropriate monies to fund necessary expenditures; and

WHEREAS, the City is the recipient of annual funding from the Department of Housing and Urban Development (“HUD”) through CDBG to be used for various social service programs, public improvement projects, and Mobility, Access and Emergency Repair program; and

WHEREAS, the City must expend \$161,000 of its CDBG funds by April 26, 2025, to meet federal expenditure requirements; and

WHEREAS, the historic windows at the Veterans Park Historic Library are in need of replacement due to safety and energy efficiency; and

WHEREAS, the facility’s window replacement is part of the Veterans Park Historic Library Improvements project, Job No. 20900; and

WHEREAS, the Veterans Park Historic Library Improvements, Job No. 20900, is a priority for the City Council; and

WHEREAS, this project qualifies as eligible Public Improvements under 24 CFR Section 570.201(c); and

WHEREAS, there is sufficient CDBG funds in the CDBG fund balance to contribute to the Veterans Historic Library project; and

WHEREAS, the City desires to appropriate these funds for the 2024-2025 fiscal year.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the amounts allocated in the budget for Fiscal Year 2024-2025 and the amounts required to meet conditions which have arisen during the budget year, require a modification in the budget appropriations; and, upon recommendation of the City Manager, the budget appropriation as adopted for Fiscal Year 2024-2025 is modified as follows:

- Sixteen thousand eight hundred fifty-nine dollars (\$16,859) of CDBG funds shall be reallocated from Mobility, Access, and Emergency Repair to the Veterans Park Historic Library Improvements, Job No. 20900.
- One hundred forty-four thousand, one hundred forty-one dollars (\$144,141) of CDBG Funds shall be reallocated from the Curb Ramp Improvement Project, Job No. 40399, to the Veterans Park Historic Library Improvements, Job No. 20900.

SECTION 2. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed and instructed to correct the budget records of said City for Fiscal Year 2024-2025 in accordance with the above modification.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
