A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, APPROVING THE STATE OF CALIFORNIA OFFICE OF TRAFFIC SAFETY (OTS) SELECTIVE TRAFFIC ENFORCEMENT PROGRAM (STEP) GRANT AGREEMENT BETWEEN THE OTS AND THE CITY OF REDONDO BEACH, AND AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT ON BEHALF OF THE CITY

WHEREAS, the City of Redondo Beach ("City") was awarded a grant from the State of California Office of Traffic Safety ("OTS") for the Selective Traffic Enforcement Program (STEP) in the amount of \$179,000;

WHEREAS, the STEP grant funds will be made available to the City for the period of October 1, 2025 to September 30, 2026;

WHEREAS, the City Council has approved the receipt of past grant funding for similar police programs;

WHEREAS, the City Police Department shall use the monies to support frontline police services directly involved in the enforcement of traffic laws as approved by the funding authority; and

WHEREAS, OTS requires that the City Council adopt a resolution approving the STEP Grant Agreement and authorizing the Mayor to execute the agreement.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the City of Redondo Beach approves the Fiscal Year 2025-2026 State of California Office of Traffic Safety Selective Traffic Enforcement Program (STEP) Grant Agreement between the Office of Traffic Safety and the City of Redondo Beach, attached hereto as Exhibit A, and authorizes the Mayor to execute the grant agreement on behalf of the City of Redondo Beach.

SECTION 2. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.

5. GRANT DESCRIPTION

Best practice strategies will be conducted to reduce the number of persons killed and injured in crashes involving alcohol and other primary crash factors. The funded strategies may include impaired driving enforcement, enforcement operations focusing on primary crash factors, distracted driving, night-time seat belt enforcement, special enforcement operations encouraging motorcycle safety, enforcement and public awareness in areas with a high number of bicycle and pedestrian crashes, and educational programs. These strategies are designed to earn media attention thus enhancing the overall deterrent effect. In addition, the department will participate in community collaboration and engagement activities to engage in conversations regarding traffic safety with community members.

- **6.** Federal Funds Allocated Under This Agreement Shall Not Exceed: \$179,000.00 Allocation is contingent upon availability of federal funds.

1. PROBLEM STATEMENT

Describe the city, county, or jurisdiction this grant will impact.

Redondo Beach is a coastal city in Los Angeles County, California, known for its relaxed beach-town vibe, recreational waterfront, and strong sense of community with a population of 71,576 (as of the US Census Bureau April 2020). It's one of the three "Beach Cities" of the South Bay. Situation along Santa Monica Bay, Redondo Beach features wide sandy beaches, a popular pier, and a scenic harbor. The city is divided into North Redondo, which is more residential, suburban, with small businesses, and South Redondo which is more coastal, tourist-focused, with the pier and marina. Redondo Beach is known for its relaxed, beach-town atmosphere, and the city is home to a scenic pier and has a rich surfing history.

Also, known for outdoor living, the community embraces surfing, sailing, volleyball, cycling, and beach activities year-round. Hiking, cycling, fishing, beach volleyball sailing, kayaking, scuba diving, paddleboarding, and snorkeling are some of the other outdoor activities popular in the area. It is also home to many waterfront restaurants catering to every taste imaginable. Popular shopping areas in the city include South Bay Galleria and Riviera Village. Many festivals and events take place in Redondo Beach throughout the year, including the BeachLife Festival, South Bay Greek Festival, and the Annual Festival of the Kite.

The Redondo Beach Pier and King Harbor Marina are central gathering spots, offering dining, shops, fishing, whale watching, and waterfront entertainment. Redondo Beah has a mix of long-time residents, families, and young professionals, creating a friendly and diverse community. The city hosts community events like summer concerts, festivals, and art walks. With its creative and laid-back vibe, Redondo attracts both locals and visitors looking for a slower pace compared to other nearby beach cities.

Like many coastal communities, Redondo Beach faces challenges with congested roadways, pedestrians' traffic, cyclists, and tourist influx, particularly near the pier and beach areas. Safety for drivers, pedestrians, and cyclists is a key focus, especially during peak tourism and event seasons. One of the best things about Redondo Beach is its central location. Los Angeles is only 22 miles away, and the main beach links it to the nearby cities of Hermosa Beach and Manhattan Beach. Redondo Beach has a large tourist industry centered on the harbor area. Because of the high number of tourists visiting, there is a significant increase in the volume of traffic, particularly in the harbor area, leading to heightened risk of crashes and congestion.

Describe the problem(s) to be addressed, supported by current and relevant crash data. (most recent calendar year data/stats).

A small portion of State Route 1, Pacific Coast Highway, serves the City of Redondo Beach as well as thousands of commuters daily. In addition to State Route 1, a majority of crashes that the Redondo Beach Police Department responds to are on three additional major arterial roads within the city limits: Inglewood Avenue, Artesia Boulevard, and Manhattan Beach Boulevard.

These high-capacity roads handle a majority of the commuter traffic feeding the 405 Freeway in both southern and northern directions. Traffic crashes along these major thoroughfares can severely impact residents and non-residents alike and redirection of vehicular traffic around an incident can send voluminous vehicular traffic through surrounding neighborhoods.

It is the mission of the Redondo Beach Police Department to continually make every effort to reduce the number of all types of alcohol related crashes, distracted driver crashes and crashes involving speed and other identified primary crash factors in order to increase the safety of all drivers, passengers, bicyclists and pedestrians.

According to the Office of Traffic Safety, in 2022, Redondo Beach recorded 41 bicyclist victims and 27 pedestrian victims, killed or injured, ranking 5th out of 104 comparable cities. These figures indicate a significant burden of harm affecting walkers and cyclists alike. These figures highlight a disproportionate impact on vulnerable road users, with bicyclist injuries standing out as particularly high. While bicyclist injuries and fatalities are notable high relative to similar cities, pedestrian incidents also contribute substantially to traffic-related harm. Also, between 2023 and 2025, Redondo Beach experienced consistent

challenges with bicycle and pedestrian safety. Bicycle crashes rose steadily from 32 in 2023, with 29 injuries and 124 citations issued, to 49 crashes in 2024 with 44 injuries and 159 citations, and further to 55 crashes in 2025 with 45 injuries and 344 citations issued. Pedestrian incidents reflected a similar pattern, with 29 injuries, 2 fatalities, and 4 citations in 2023; 27 injuries and 10 citations in 2024; and 32 injuries with 12 citations in 2025. While pedestrian fatalities were limited to 2023, both bicycle and pedestrian injuries and enforcement actions show a consistent and concerning trend. These figures highlight the persistent dangers faced by vulnerable road users in Redondo Beach and emphasize the need for continued education, enforcement, and safety interventions to reduce crashes, injuries, and fatalities.

The congestion of activity along high-use corridors, such as along the Waterfront area, where bicycle and pedestrian volumes peak likely exacerbate exposure and vulnerability to crashes. Also, the city's busy coastal corridors and residential streets near schools create environments where both pedestrians and cyclists are at increased risk. Of particular concern is the number of children riding their bikes to and from school. Without proper protective gear, such as helmets, young riders face greater vulnerability to serious injury in the event of a crash. This underscores the urgent need for targeted safety initiatives, including helmet distribution and education campaigns, to reduce risks for children and improve overall bike and pedestrian safety within Redondo Beach. The target population will be young children. The city's ranking for pedestrian injuries among this age group (15 years and under) is 67th, while bicyclist injuries for under-15 ranked 14th out of 104. This suggests that while young pedestrians fare comparatively better, bicyclist injuries remain a critical concern for children. Redondo Beach PD will implement Bicycle Rodeos at local schools, recreation centers, and community events. Through rodeos, trained personnel will provide handson instruction to children by educating the children about safe riding skills, traffic awareness, and helmet safety, while also properly fitting and distributing the helmets to those children who need them. Targeting children under 15 aligns with the identified high injury ranking for bicyclist incidents in that age group and allows for early education in safe riding behaviors.

There are also two target areas of traffic related issues that all the Redondo Beach Police Department officers would focus upon: commuter traffic and harbor area leisure traffic. Also, speed maintains a significant issue in Redondo Beach. On average, the department encounters on average 6 injury crashes per month where speed is the primary crash factor. Due to our focused efforts, the department issued approximately 21 speed citations a month. In 2023, there were 83 crashes caused by speeding with no fatalities. In 2024, there has been 63 crashes caused by speeding with one fatality. In 2023, the Redondo Beach Police Department issued 218 citations for speed (YTD).

The top three primary crash factors are unsafe turning movement, unsafe speed, and driving under the influence. Unsafe turning movement resulted in 27 crashes with 29 injured victims. Unsafe speeding caused one fatal crash with one victim killed, as well as causing 50 crashes resulting in 67 victims injured. Driving under the influence caused one fatal crash one victim killed, as well as causing an additional 19 crashes, with 25 victims injured. These factors highlight the urgent need for targeted strategies to reduce crashes and improve roadway safety. By addressing these leading causes, we can work together to make our roads safer for everyone by conducting enforcements, through education, press releases, and community collaboration.

The Redondo Beach Police Department responded to 1418 calls for service regarding traffic crashes in the 2024 Federal Fiscal year. Of those 1418 calls, 534 generated reports, 225 involved injury or complaint of pain, 6 involved in fatalities, and there was a total of 300 people injured. In the Calander year of 2024, we had 6 Fatal Traffic Crashes.

Define the target population the grant intends to serve and how they are affected by the problem(s).

The Redondo Police Department will continue to serve the residents, visitors, and commuters of our community who utilize the city's roadways daily. Redondo Beach is a popular coastal destination that attracts large numbers of tourists to its pier, harbor, and beaches while also supporting a strong residential community and commuter population. This combination results in heavy traffic volumes, increased pedestrian activity, and significant bicycle use throughout the city.

The target population is directly affected by unsafe driving behaviors such as speeding, impaired driving, and distracted driving, which create elevated risks for crashes involving not only motorists but also pedestrians and cyclists. The influx of visitors during weekends and seasonable events further compounds roadway congestion and safety challenges.

It is our goal to ensure the safety of all individuals traveling on our roadways through proactive and targeted efforts. This includes conducting high-visibility enforcement operations, DUI/DL Checkpoints, and public education campaigns. In addition, we strive to build trust and strength relationships within the community through collaboration and engagement events. By combining enforcement with outreach and education, we will reduce dangerous driving behaviors and promote a culture of traffic safety for everyone. A reduction in traffic crashes makes for a safer driving environment and enhances the quality of life for drivers and residents alike in the City of Redondo Beach as well as neighboring communities.

enhance the overall deterrent effect and promote high visibility, it is recommended the grantee issue an advance press release and conduct social media activity for each checkpoint. For combination DUI/DL checkpoints, departments should issue press releases that mention DL's will be checked at the DUI/DL checkpoint. Signs for DUI/DL checkpoints should read "DUI/Driver's License Checkpoint Ahead." OTS does not fund or support independent DL checkpoints. Only on an exception basis and with OTS pre-approval will OTS fund checkpoints that begin prior to 1800 hours. When possible, DUI/DL Checkpoint screeners should be DRE- or ARIDE-trained.

3. METHOD OF PROCEDURE

A. Phase 1 – Program Preparation (1st Quarter of Grant Year)

- The department will develop operational plans to implement the "best practice" strategies outlined in the objectives section.
- Conduct all training needed to implement the program, in the first quarter.
- Purchase all grant related supplies and materials to implement the program, in the first quarter.
- Items with a unit cost of \$5,000 more (including tax and shipping) must comply with Buy America.
- In order to develop/maintain the "DUI BOLOs," research will be conducted to identify the "worst of the worst" repeat DUI offenders with a suspended or revoked license as a result of DUI convictions. The DUI BOLO may include the driver's name, last known address, DOB, description, current license status, and the number of times suspended or revoked for DUI. DUI BOLOs should be updated and distributed to traffic and patrol officers at least monthly.
- Implementation of the STEP grant activities will be accomplished by deploying personnel at high crash locations.

Media Requirements

Issue a news release approved by the OTS PIO announcing the kick-off of the grant by December 31 and after the grant is signed and executed, but no sooner than October 1, the start of the grant year. The kick-off release must be approved by the OTS PIO. If you are unable to meet the December 31 deadline to issue a kick-off press release, communicate reasons to your OTS grant coordinator and OTS PIO.

- Send all media advisories, alerts, videos, graphics, artwork, posters, radio/PSA/video scripts, storyboards, digital and/or print educational materials for grant-related activities to the OTS PIO at pio@ots.ca.gov for approval and copy your OTS grant coordinator. Optimum lead time would be 7 days before the scheduled release but at least 3 business days prior to the scheduled release date for review and approval is appreciated.
- Send all PowerPoint presentations, online presentations and trainings for grant-related activities
 to the OTS PIO at <u>pio@ots.ca.gov</u> for approval and copy your OTS grant coordinator. Certified
 training courses are EXEMPT from the approval process.
- The OTS PIO is responsible for the approval of the design and content of materials. The agency understands OTS PIO approval is not authorizing approval of budget expenditure or cost. Any cost approvals must come from the OTS grant coordinator.
- Pre-approval is not required when using any OTS-supplied template for media advisories, news
 releases, social media graphics, videos or posts, or any other OTS-supplied educational material.
 However, copy the OTS PIO at pio@ots.ca.gov and your OTS grant coordinator when any
 material is distributed to the media and public, such as a news release, educational material, or
 link to social media post.
- If an OTS-supplied template, educational material, social media graphic, post or video is substantially changed, the changes shall be sent to the OTS PIO at pio@ots.ca.gov for approval and copy your OTS grant coordinator.
- News releases, social media posts and alerts on platforms such as NextDoor and Nixle reporting
 immediate and time-sensitive grant activities (e.g. enforcement operations, day of event
 highlights or announcements, event invites) are EXEMPT from the OTS PIO approval process.
 The OTS PIO and your OTS grant coordinator should still be notified when the grant-related

- Email the OTS PIO at pio@ots.ca.gov and copy your OTS grant coordinator at least 21 days in advance, or when first confirmed, a short description of any significant grant-related traffic safety event or program, particularly events that are highly publicized beforehand with anticipated media coverage so OTS has sufficient notice to arrange for attendance and/or participation in the event. If unable to attend, email the OTS PIO and coordinator brief highlights and/or results, including any media coverage (broadcast, digital, print) of event within 7 days following significant grant-related event or program. Media and program highlights are to be reflected in QPRs.

 or informational materials that received OTS PIO approval in a prior grant year needs to be
