THIRD AMENDMENT TO THE AGREEMENT FOR CONSULTING SERVICES BETWEEN THE CITY OF REDONDO BEACH AND FHN FINANCIAL MAIN STREET ADVISORS, LLC

THIS THIRD AMENDMENT TO THE AGREEMENT FOR CONSULTING SERVICES ("Third Amendment") is made between the City of Redondo Beach, a chartered municipal corporation ("City") and Meeder Public Funds, Inc., an Ohio corporation ("Contractor" or "Consultant") formerly FHN Financial Main Street Advisors, LLC ("FHN").

WHEREAS, on February 18, 2020, the City and FHN entered into that certain Agreement for Consulting Services (the "Agreement");

WHEREAS, on August 17, 2021, the City and FHN entered into the First Amendment to the Agreement to remove certain services and define nondiscretionary investment management;

WHEREAS, on January 17, 2023, the City and FHN entered into a Second Amendment to the Agreement to extend the Agreement through January 31, 2026;

WHEREAS, on November 21, 2023, the City consented, pursuant to that certain Consent to Assignment of the Agreement, to the assignment of the Agreement from FHN to Meeder Investment Management, Inc., and the subsequent assignment from Meeder Investment Management, Inc. to Consultant, which assumed all rights and obligations of FHN under the Agreement; and

WHEREAS, the City and Consultant now desire to extend the term of the Agreement.

NOW THEREFORE, in consideration of the promises and mutual covenants contained herein, and intending to be legally bound, the parties hereby agree to make the following amendment to the Agreement:

- 1. **TERM AND TIME OF COMPLETION**. Exhibit "B" of the Agreement, as amended by Exhibit "B-1", is hereby amended to add Exhibit "B-2", which extends the Agreement to January 31, 2029. Exhibit "B-2" is attached hereto and incorporated by reference. Consultant shall commence and complete all services described in Exhibit "A", as amended by Exhibit "A-1" of the Agreement in accordance with the schedule set forth in Exhibit "B", as amended by Exhibits "B-1" and "B-2".
- 2. NO OTHER AMENDMENTS. Except as expressly stated herein, the Agreement shall remain unchanged and in full force and effect. The Agreement, First Amendment, Second Amendment, Consent to Assignment, and this Third Amendment constitute the entire agreement between the parties and supersede any previous oral or written agreement with respect to the subject matter hereof. In the event of any inconsistency between the terms of the Agreement, First Amendment, Second Amendment, Consent to Assignment, and this Third Amendment, the terms of this Third Amendment shall govern.
