

## **Overall Sentiment**







The timing of this discussion—during the busy holiday season—raises some concerns. I'd appreciate it if the Council could vote tonight to establish a delivery-only model and set a tax rate for delivery services. A physical

retail storefront is NOT required for delivery-only businesses, but the owner or entity must have a warehouse for cannabis storage. Had we implemented this model earlier, the city could have begun collecting taxes in 2024.

I encourage you to read the SFGate.com article titled 'Teetering on the edge': Calif. Pot shops owe \$1.3 billion in back taxes. After reading it, I strongly believe that NO city should consider opening any new retail cannabis stores until existing stores have paid all taxes owed to the state.

Furthermore, I have the following comments:

- \*\*Could not find a section addressing termination for non-compliance. Could this be included?
- \*\*There was no mention of a buffer zone between cannabis retail stores and smoke shops, massage businesses, or bars. What is the required buffer zone? Could it be set at 1,000 feet, measured from the nearest property lines of the affected parcels?
- \*\*I did not see a buffer zone requirement between cannabis retail stores and residences. Can City Staff determine an appropriate buffer distance?
- \*\*Consider single-entity ownership for cannabis businesses. This simplifies operations, reduces challenges in decision-making, and minimizes management complexity. Partnerships or aggregate ownership structures could lead to complications.
- \*\*The fiscal impact of retail cannabis operations ranges from \$150K to \$500K annually, based on a tax rate of 3%-5%. However, this estimate is relatively modest, as it's unclear how much revenue the city could collect from a delivery-only model. Could City Staff calculate potential revenues for a delivery-only model to allow for comparison?

Voters have elected you to represent our interests, particularly when it comes to protecting our youth and quality of life. In that spirit, I respectfully request that the Council consider adopting a delivery-only model and making the necessary updates to the relevant ordinances.
