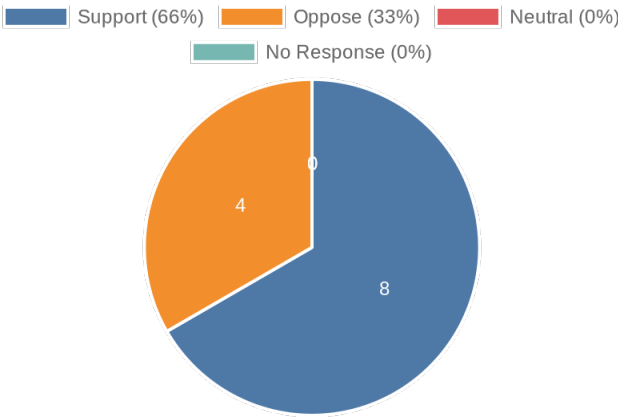

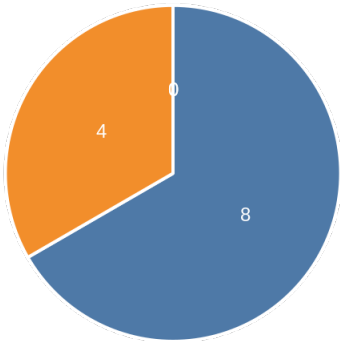

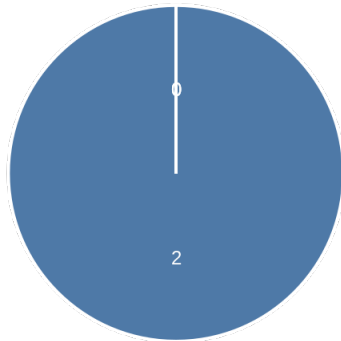

Glad to see Manhattan Beach and El Segundo agreeing to cost sharing for Line 109. Hopefully Hermosa Beach joins soon. In speaking with transit advocates in the Beach Cities and riders of Beach Cities Transit and Torrance Transit, there's a real need to improve the 109 Route to better serve Beach Cities residents. The goal should be to get everyday people riding transit more, and to create a more useful service that serves as an alternative to driving and parking at the beach, one that councilmembers would choose to take over driving. Transit should be so frequent and ubiquitous that everyone wants to ride it. Currently, unless you really plan your trip around the BCT schedule, it's difficult to justify a transit trip over driving or biking.

Advocates would love to speak with BCT staff on potential improvements to Line 109 (and 102). In general, several suggestions are: update and straighten out the routing of Line 109 using ridership data, increase service frequency to every 20-30 minutes including on weekends, facilitate better connections to RB Marine K Line Station to enhance rail ridership, market Line 109 as an alternative to driving/parking at the beach, and implement trolley-type service similar to the popular San Clemente Trolleys for an overall more frequent, connected, and convenient network.

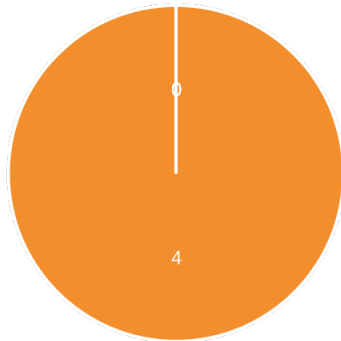

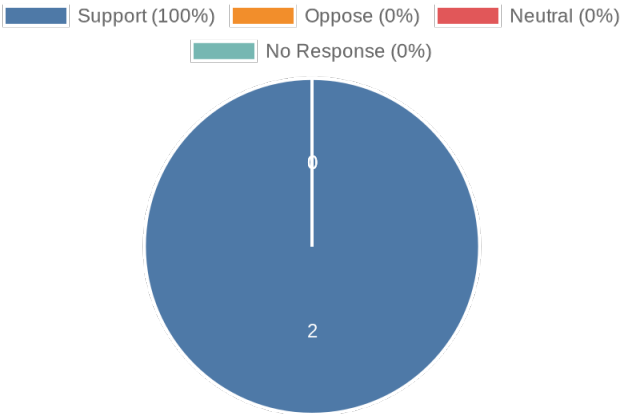

On transit specifically, I think it would be really good moving forwards to see a focus on frequency and connectivity for BCT. I wonder if we could turn some street parking lanes on busier streets into bus lanes in order to get more out of our existing buses, making them faster and more consistent.

I appreciate the diligence of the city council and staff in crafting and executing the city's strategic plan. I am happy to see alignment in the Strategic Plan on a number of shared goals expressed in South Bay Forward's 2025

Redondo Beach policy and budget priorities (<https://www.southbayforward.org/blog/south-bay-forwards-2025-policy-budgeting-priorities-for-redondo-beach>).

In particular, we are grateful to see recent policy reforms moving forward on Artesia and Aviation Corridor to improve walkability and reinvestment by eliminating commercial parking requirements and increase the FAR. On the city's approach to addressing homelessness, it's great to see pallet shelter expansion moving forward and exploration of family supportive housing and foster youth housing. There is still more we can do to facilitate senior housing, affordable housing, and transit-oriented housing in the city and I hope there is consensus on this.

For the Alternative Transportation Options: Thank you for moving forward the item to join Metro's GoPass. We now need RBUSD to enroll so that youth can access free transit passes. We commend the city for its leadership on active transportation and bicycle infrastructure and look forward to updates on the implementation of the Bicycle Master Plan and from the South Bay Bicycle Coalition. For Beach Cities Transit, several suggested improvements include: update the routing of Line 109, enhance first-last mile connections to RB Marine K Line Station by bike and bus, more frequent service, marketing Line 109 as an alternative to driving/parking at the beach, and trolley-type service similar to San Clemente Trolleys for an overall more useful network. We appreciate the city for its openness to work in dialogue with advocates to enhance and improve these services.

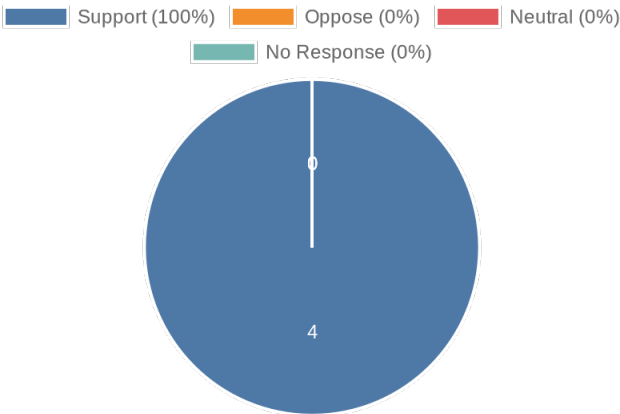

This item represents the culmination of years of community input and thoughtful planning to bring forward some very exciting active transportation projects in the city. I'm grateful to city council and city staff for bringing this item along and I ask that you support and approve it today. Redondo Beach has completed 33% (and counting) of its portion of the South Bay Bicycle Master Plan--a clear leader in the region on building out a safe and comprehensive bike network.

NRBB Extension to Grant Ave and Mobility Hub: This is a really appealing project that will add new park space, native gardens, and rest areas for people who pass through this portion of the city on foot or bike. This project will link multiple mobility projects: the NRB Bikeway, the Redondo Beach Blvd MAT Corridor, and the Redondo Beach Transit Center. Please consider the inclusion of the following items: benches for seating and water bottle filling stations.

Redondo Beach Blvd MAT Project: I strongly support this project and the extensive community outreach which revealed strong preferences for Class IV bike lanes and cycle tracks throughout the project. Thank you for planning for Class IV facilities for the Redondo Beach portion. This is a multi-jurisdictional project, with differing levels of cooperation across the jurisdictions. Redondo Beach is the lead agency. I ask you to endorse the recommendations in the letter submitted by South Bay Forward and South Bay Bicycle Coalition for Class IV protected lanes in Torrance, Lawndale, and LA County on 190th St and Redondo Beach Blvd. This is technically feasible without removing car lanes and there is still opportunity at 15% design. Advocates in those cities have expressed to their city councils their preference to update design and have been met with varying levels of resistance, so we would like your official support. I ask that you endorse the recommendations in the coalition letter and express your position to Lawndale, Torrance, and LA County for a fully protected Class IV route from Redondo to El Camino College.
