

## **Overall Sentiment**





#### **Overall Sentiment**







As a former gymnast and employee of Fit Kids Gymnastics Center, a former resident of Redondo Beach, and a current law enforcement officer in the Southern California region, I urge the planning commission to deny the exemption declaration and request for a conditional use permit for the operation of Aerial Gymnastics Club (AGC) at the proposed location. Aside from the personal bias all commenters have expressed, there are safety concerns regarding this location that should be addressed. This location does not allow for the safe drop off an pick up of children, in the front or rear of the facility. I have coached at three different gymnastics facilities throughout California: Fit Kids, Bay Aerials Gymnastics in Fremont, CA and Starz Gymnastics in Ukiah, CA. All three locations had plenty of parking to accommodate all classes, staff, and spectators. AGC proposed location simply does not have the space to accommodate the business. Parking in the rear is minimal to perhaps accommodate morning classes, but would never work for gymnastics camps, shows, or busy evenings with full classes. Based upon AGC claims of high waitlists, the parking lot traffic will be a problem, especially for the front of the facility. When parking in the rear of the facility is full families will attempt to park in the front of the facility where parking is already impacted by the present businesses. My family, who live in Redondo Beach, and I often eat at Havana Maina. If parking was impacted, we simply would not eat there any longer. I believe many patrons

of these businesses would avoid the shopping complex if they could not find parking, which in turn will be detrimental to current businesses in the shopping complex. Parking lot traffic collisions happen, but I believe with this type of facility in this shopping complex, there is a high probability of an increase of collisions. The increase in pedestrian traffic for the proposed facility will also give way to protentional pedestrian vs. vehicle collisions within the parking lot, with those pedestrians being children. Please consider the parking lot safety concerns and liability to the City of Redondo Beach when making your decision.

I oppose the approval of a conditional use permit that would allow Aerial Gymnastics Club to open their facility in this particular location. I am a current employee of Fit Kids and have been with the company for almost 20 years. Fit Kids is not attempting to completely prevent this club from doing business in Redondo Beach, and in fact did not previously make any attempts to prevent them from doing business when they opened a facility less than a mile from Fit Kids' Torrance location. AGC's strategy continues to look and feel like a predatory one because of their actions in the past and present. Not very many people even have a lot of knowledge about the sport of gymnastics, let alone the logistics of running a gymnastics business for children. Of the approximately 5,000 colleges in the US only 86 offer women's gymnastics programs, and a staggering 15 offer men's gymnastics programs. I hope this puts in perspective why this businesses supply/demand cannot be compared to that of coffee shops, restaurants, drug stores, or even other youth sports. The required knowledge, temperament, and continued training of an employee does not compare to most industry's. This is a niche sport and a niche business that cannot withstand 2 separate businesses competing next door to each other, for customers and employees, in a city with half the amount of residents of Torrance. Aside from these facts, the location they have chosen is going to put customers at risk, cause other tenants frustration, and possibly put a strain on the flow of traffic on Inglewood Avenue and Manhattan Beach Blvd. The parking lot is already congested because of the current patrons frequenting this shopping center, but adding crowds of children to this is going to be a liability and tragedy for someone. A safer and less intrusive location can be found for AGC to continue thriving.

I am writing to strongly oppose the proposed CUP that would allow Aerial Gymnastics Club to open. This proposal raises serious concerns on multiple levels—economic, ethical, and public safety.

AGC is yet again attempting to open in close proximity to Fit Kids Gymnastics Center Gymnastics programs are not high-volume walk-in services; they rely on long-term commitment, personalized instruction, and a loyal base of families. Situating two nearly identical facilities in such close quarters doesn't foster competition—it fractures the existing customer base and destabilizes a program that has been serving this community for years. There's also the issue of professional boundaries. The owners of Aerial Gymnastics Club previously worked with and had close ties to Fit Kids. While starting a business is commendable, opening it in this specific location—so near to their former employer—raises questions about ethical business practices and the responsible use of insider knowledge or established relationships.

Beyond economic and ethical concerns, the proposed location poses significant safety issues. The shopping center in question is not designed to support a child-centered facility. It's heavily trafficked, poorly lit, and the immediate surroundings include a gas station, a smoke shop, and freeway ramps.

This isn't about opposing new businesses. It's about ensuring that any new development contributes to a healthy, safe, and sustainable community.

On top of these concerns, it's been disheartening to see some supporters of the new proposal resort to spreading misinformation about the existing gym and its leadership. Public decisions should be based on facts and community need. But instead AGC's plan is to fire false narratives aimed at undermining the competition. Is this the reputation AGC wants?

Redondo Beach should expect more from any business seeking to serve its families—more respect, more responsibility, and more transparency. This proposal doesn't meet that standard. I respectfully ask the Commission to deny this permit and prioritize long-term community well-being over short-term business opportunity.

As a Redondo Beach resident, a mother, a therapist for children and teens, and the wife of a police officer, I feel deeply compelled to speak out against the proposed opening of Aerial Gymnastics Club at the former 99 Cents Only Store on Manhattan Beach Blvd and Inglewood Ave. This location is fundamentally unsafe for a child-centered business. The shopping center is poorly lit, has no designated pedestrian or drop-off zones, and is adjacent to a gas station and smoke shop that routinely attract loitering and suspicious activity. Critically, it sits directly next to on- and off-ramps for the 405 freeway—creating a heightened security risk due to how easily someone could enter or flee the area. No significant safety improvements have been proposed to address these concerns.

Additionally, incidents of theft, verbal aggression, and police response calls have been reported in or around the plaza. Families dropping off children for evening classes will face increased risk in an environment not designed for youth-focused activity. There are serious logistical and public safety flaws that should not be overlooked in pursuit of commercial development.

Equally troubling is the apparent strategy of the proposed gym's supporters. Instead of offering clear plans or community engagement, they've chosen to spread false and personal claims about Fit Kids Gymnastics—a long-standing, trusted business in our community. Some have suggested Fit Kids does not support children with special needs. That is entirely untrue.

Yes, Fit Kids is owned by a man. But it is run by a team of women who are deeply committed to every child who walks through the doors. The owner is fully invested in creating a safe, inclusive, and nurturing environment. As someone who entrusts him with my own children, it is disheartening to see his integrity questioned by non-residents making defamatory claims in an apparent attempt to sway the city.

Redondo Beach families deserve more than vague promises and marketing spin. We deserve transparency, professionalism, and safety. I urge the Planning Commission to deny the CUP and protect our children, our standards, and our community.

I was proudly employed by Fit Kids Gymnastics Center for 15 years. Chris Olsen, Founder & President, gave me my first job—his cell number is still one of the few I know by heart. If you ever need someone, Chris shows up. It's that character, integrity, and consistency that's allowed Fit Kids to serve the South Bay community for nearly four

decades—21 years right here in Redondo Beach. Now, it's my turn to show up for him.

Approval of CUP 2025-0015 threatens the future of Fit Kids and the livelihoods it supports. AGC's proposed address isn't just close—it's nearly identical: 2701 / 2641 Manhattan Beach Blvd. I support family choice, but the Commission deserves full context.

AGC claims to meet growing demand, but reality is more complex. Members of the Snyder family—owners of AGC—were once employees and customers of FKGC. They were part of our community for many years. Like most businesses, Fit Kids made difficult layoffs during the pandemic to stay afloat. The Snyders, however, had the means to open AGC, and I commend their success. Still, I oppose granting a permit that allows them to operate in such proximity to a former employer. It raises serious concerns about competitive fairness and the potential misuse of relationships or insider knowledge gained while at Fit Kids.

This isn't about blocking competition—it's about WHERE it happens. This isn't a coffee shop scenario. Gymnastics isn't a walk-in business. It's a niche, relationship-based sport with high investment of families' time, cost, and trust. Customer base is more limited, and competition of similar programs within 300 feet of each other undermines the integrity of our local business environment. Yes, AGC and FKGC both operate in Torrance—but Torrance spans 21 square miles. Redondo Beach is just 6. The scale isn't comparable.

The proposed site also raises safety concerns: it's in a congested shopping center with limited parking and heavy traffic. Without a comprehensive traffic study, the risks—especially to children—cannot be ignored.

Approving this permit would not grow the local market—it would divide it. One program would likely replace the other. That's not healthy competition; that's a loss.

As a South Bay resident and the parent of a young gymnast, I am writing to express my strong support for the Conditional Use Permit (CUP) application for the Aerial Gymnastics Club at 2701 Manhattan Beach Boulevard in Redondo Beach.

The instruction and mentorship at Aerial Gymnastics Club are exceptional, and since joining, my child has gained not only physical skills but also confidence that carries into academics and daily life. As a concerned community member, I respectfully oppose the approval of CUP 2025-0015 allowing Aerial Gymnastics Club to operate directly next door to the long-standing Fit Kids Gymnastics Center at 2701 Manhattan Beach Blvd.

Before moving forward, I ask: Do current zoning regulations not prevent two nearly identical, niche businesses from operating wall-to-wall? It seems counterintuitive to city planning and raises questions about permitting standards.

- Questionable Intent & Bad Faith: This proposal is not rooted in opportunity, but in personal history. John Snyder's daughters were previously coached at Fit Kids, and his actions reflect a pattern—this isn't the first time Aerial Gymnastics Club has opened near a Fit Kids location, as seen in Torrance. - No Public Need Justifies This: There is no overcrowding or underserved gymnastics demand in this area. This is not a grocery store or gas station where proximity increases convenience. Gymnastics training is niche and deeply trust-based. Opening another gym next door creates confusion, not choice.
- Redondo Deserves Smarter Growth: If Redondo Beach wants real expansion and increased revenue, it should encourage geographic diversity—not saturation. Requiring some separation between similar businesses would drive broader engagement, higher tax revenue, and a better distribution of services citywide.
