



I support this ordinance to eliminate parking requirements on Artesia and Aviation. I think it's the right move to make to encourage more investment in the corridor and facilitate more walkable street-level environments and building envelopes alongside an FAR increase. I am supportive of the direction the council and staff are moving to apply evidence-based planning principles to allow the area to reach its potential as a vibrant community-serving district. This is a key reform and a low-hanging fruit to implement.

I also support future considerations by the council to allow for a residential overlay and eliminate parking requirements for residential uses as well. When implemented in other cities (thousands of cities in the U.S. have done so including Culver City) the removal of costly parking mandates has enabled more production of much-needed housing, with projects still including parking based on what the projected needs of residents are, rather than arbitrary formulas set by city code.
