FIRST AMENDMENT TO THE CONSULTING SERVICES AGREEMENT BETWEEN THE CITY OF REDONDO BEACH AND REVIZE, LLC

THIS FIRST AMENDMENT TO THE AGREEMENT FOR CONSULTING SERVICES ("First Amendment") is made between the City of Redondo Beach, a chartered municipal corporation ("City") and Revize, LLC., a Michigan limited liability company ("Contractor" or "Consultant").

WHEREAS, on November 15, 2022, the parties hereto originally entered into the Agreement for Consulting Services between the City and Contractor (the "Agreement"); and

WHEREAS, the parties wish to amend the Agreement to add services, extend the term and to increase compensation.

NOW THEREFORE, in consideration of the promises and mutual covenants contained herein, and intending to be legally bound, the parties hereby agree to make the following amendment to the Agreement:

- A. **Scope of Services**: Exhibit "A" of the Agreement is hereby amended to add Exhibit "A-1" to add the services of Revise Al ChatBot. Exhibit "A-1" is attached hereto and incorporated herein by this reference.
- B. <u>Term.</u> Exhibit "B" of the Agreement is hereby amended to add Exhibit "B-1" to extend the term of the Agreement for five additional years commencing on November 7, 2025 and expiring November 6, 2028, with two one-year extensions unless terminated as provided in the Agreement. Exhibit "B-1" is attached hereto and incorporated herein by this reference.
- C. <u>Compensation</u>. Exhibit "C" of the Agreement is hereby amended to add Exhibit "C-1" incorporating an additional amount of \$18,500 for "Services AI" to maintain the AI Chatbot on the City's website. Exhibit "C-1" is attached hereto and incorporated herein by this reference.
- D. <u>No Other Amendments</u>. Except as expressly stated herein, the Agreement shall remain unchanged and in full force and effect. The Agreement and this First Amendment constitute the entire agreement between the parties and supersede any previous oral or written agreement with respect to the subject matter hereof. In the event of any inconsistency between the terms of the Agreement and this First Amendment, the terms of this First Amendment shall govern.

<u>Term</u>. The term of this Agreement shall commence November 7, 2025 and expire November 6, 2028 ("Term") with two one-year extensions, which can be exercised by the City, through the IT Director, by providing written notice to Revize within 30 days of then terminating date; unless otherwise terminated as herein provided.

EXHIBIT "C-1" Pursuant to First Amendment

An additional amount of \$17,000 is added to the compensation for the additional AI ChatBot product described in Exhibit "A-1." The AI service shall provide the AI ChatBot on the City's website. The pricing for the AI ChatBot is \$3,400 annually for Years 4-8 of the Agreement. An additional \$29,100 is also being added to the compensation for Website Hosting and Maintenance for Years 6-8 of the Agreement.

This added compensation increases the total not-to-exceed amount to \$166,100.

All other terms of Exhibit C remain in full force and effect.
