# **EXECUTIVE SUMMARY**

The City Charter requires that the annual budget be adopted by June 30 each year. Public Hearings for the proposed FY 2025-26 Budget and the 2025-30 Capital Improvement Program are scheduled to begin on June 3, 2025 and conclude with budget adoption on June 17, 2025.

# **BACKGROUND**

As presented, the Fiscal Year 2025-2026 City Manager's Proposed Budget is balanced and was developed pursuant to the City Council's adopted financial principles. The 2025-2030 City Manager's Proposed Five-Year Capital Improvement Program identifies capital investment required to meet the City's General Plan and other policy goals and to ensure good stewardship of existing infrastructure.

In addition to pdf versions of the Operating and Capital Improvement Program Budget documents, the City Council and members of the public can access a digital version of the budget book via the same link.
