

**ADDENDUM

FIRST AMENDED MEMORANDUM OF AGREEMENT

Between

**DEPARTMENT OF HOMELAND SECURITY
HOMELAND SECURITY INVESTIGATIONS, LOS ANGELES**

And

THE CITY OF REDONDO BEACH POLICE ("CITY")

This Addendum formally constitutes the addition of the CITY to the El Camino Real Financial Crimes Task Force as a FULL-TIME participating federal agency and shall become effective upon the signature of HSI and the CITY. Once this Addendum is executed, CITY will become a signatory to the First Amended Memorandum of Agreement, Southern California High Intensity Financial Crimes Area (HIFCA), El Camino Real (ECR) Financial Crimes Task Force, dated February 26, 2021, hereinafter referred to as the "First Amended MOA," which is attached to and made a part of this document. CITY further acknowledges acceptance of the First Amended MOA's terms and participation in the ECR, and the ECR Director will add the CITY to the list of participating agencies in the ECR.

Where the First Amended MOA refers to "addendum" or "addenda" as it pertains to both HSI and the CITY, this Addendum shall be incorporated by reference therein. Otherwise, the execution of this Addendum shall have no effect on the operability or interpretation of the First Amended MOA, or of other addenda that may have been signed or will be signed by HSI and other participating agencies. Unless otherwise specified for in this Addendum, the terms of the First Amended MOA shall govern the CITY participation in the ECR. Accordingly, CITY agrees to adhere to and abide by the terms of the First Amended MOA throughout the duration of its participation in the ECR.

This Addendum shall continue to be in effect unless and until it is modified, terminated or rescinded, or until the ECR is dissolved.

1. PARTICIPATION

The CITY shall assign at least one (1) FULL-TIME DETECTIVE from the CITY Police Department (“RBPD”) to initiate and support ECR investigations and activities, and coordinate ECR activities with RBPD.

2. AMENDMENTS

Any and all amendments to this Addendum are effective upon the signature of HSI and the CITY. The parties herein are only bound by those terms and conditions to which they have expressly agreed through mutual signatures.

3. WITHDRAWAL

HSI or the CITY may withdraw at any time from this Addendum by providing thirty (30) days' written notice to the ECR Director. Withdrawal from this Addendum by HSI or the CITY will render this Addendum null and void and will constitute the CITY withdrawal from the First Amended MOA and the ECR. A withdrawal will not otherwise affect the operability of the ECR, the First Amended MOA, or any addenda signed with any other participating agencies.
