

RESOLUTION NO. CC-2608-069

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL YEAR 2026-2027 BUDGET MODIFICATION TO ALLOCATE \$69,152 FROM THE CITY OF EL SEGUNDO AND \$19,761 FROM THE CITY OF HERMOSA BEACH, FOR A TOTAL OF \$88,913 FOR THE BEACH CITIES TRANSIT LINE 109 COST SHARING TO THE TRANSIT FUND

WHEREAS, it is the intention of the City Council of Redondo Beach ("City Council") to review the adopted budget from time to time;

WHEREAS, the City of Redondo Beach's adopted budget needs to be modified to allocate monies from outside sources to fund necessary expenditures;

WHEREAS, the City of Redondo Beach ("City") and the Cities of Hermosa Beach and El Segundo entered into Transit Service Operations Agreements (the "Agreements"), effective July 1, 2026, under which the City will provide Beach Cities Transit ("BCT") Line 109 service throughout the Cities of Hermosa Beach and El Segundo;

WHEREAS, pursuant to the Agreements, the City of El Segundo will contribute \$69,152 and the City of Hermosa Beach will contribute \$19,761, for a total of \$88,913 to the City to support BCT Line 109 operations throughout the Cities of Hermosa Beach and El Segundo; and

WHEREAS, the \$88,913 contribution from the Cities of Hermosa Beach and El Segundo was not included in the adopted Fiscal Year 2026-2027 Budget, and a budget modification is necessary to recognize the additional revenue and allocate the funds to the Transit Fund to support bus operations for BCT Line 109.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The amounts allocated in the Fiscal Year 2026-2027 Budget need to be modified to recognize additional revenue received during the budget year; and, upon recommendation of the City Manager, the budget as adopted for Fiscal Year 2026-2027 is modified as follows:

Funds in the amount of sixty-nine thousand, one hundred fifty-two dollars (\$69,152) from the City of El Segundo and nineteen thousand, seven hundred sixty-one dollars (\$19,761) from the City of Hermosa Beach, for a total of eighty-eight thousand, nine hundred thirteen dollars (\$88,913) shall be allocated to the Transit Fund.

SECTION 2. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2026-2027 in accordance with the above modification.

SECTION 3. This Resolution shall take effect immediately upon its adoption by the City Council.

SECTION 4. The City Clerk shall certify to the passage and adoption of this resolution and shall

enter the same in the Book of Original Resolutions.
