

RESOLUTION NO. CC-2608-063

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AMENDING THE HOURLY PARKING RATE AT THE PIER AND PLAZA PARKING STRUCTURES AND THE MARINA PARKING LOT FROM \$2.00 TO \$2.25 PER HOUR, EFFECTIVE AUGUST 20, 2026, CONSISTENT WITH THE EFFECTIVE DATE OF THE CITYWIDE PARKING METER RATE INCREASE UNDER ORDINANCE NO. 3313-26

WHEREAS, the City of Redondo Beach ("City") owns and operates the Pier and Plaza Parking Structures and the Marina Parking Lot along its Waterfront; and

WHEREAS, pursuant to Redondo Beach Municipal Code ("RBMC") Section 3-6.03(d), the parking rates at the Pier and Plaza off-street parking structures are set by resolution of the City Council; and

WHEREAS, the Marina Parking Lot is owned and managed by the City and constitutes a "municipal parking facility" as defined in RBMC Section 3-10.01; and

WHEREAS, pursuant to RBMC Section 3-10.04, the City Council may by resolution establish the fees or charges for parking at municipal parking facilities; and

WHEREAS, on June 16, 2026, the City Council adopted the Fiscal Year 2026-2027 operating budget, which included a \$0.25 per hour increase to City parking rates, from \$2.00 per hour to \$2.25 per hour; and

WHEREAS, concurrently with this Resolution, the City Council has introduced Ordinance No. 3313-26, amending RBMC Section 3-6.03 to apply the same \$0.25 per hour increase to the City's on-street and off-street parking meter rates; and

WHEREAS, the City's Pier and Plaza Parking Structures and the Marina Parking Lot are located within the Coastal Zone and any rate adjustment must remain consistent with California Coastal Commission regulations limiting parking rate increases to no more than fifty percent (50%) over a consecutive three-year period; and

WHEREAS, the City Council desires to apply the same \$2.25 per hour rate, effective August 20, 2026, to the Pier and Plaza Parking Structures and the Marina Parking Lot, consistent with the citywide rate adjustment.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That, effective August 20, 2026, the hourly parking rate at the Pier and Plaza Parking Structures and the Marina Parking Lot shall be \$2.25 per hour, in place of the current rate of \$2.00 per hour.

SECTION 2. That signage at the Pier and Plaza Parking Structures and the Marina Parking Lot reflecting the new rate shall be updated prior to the effective date of this Resolution.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
