Councilmember Horvath explained he pulled this item as he does not agree with it and feels City Council went too far as it relates to City Council salaries.

Councilmember Emdee noted the Redondo Beach City Council is already one of the highest paid Council; reported other options were presented when the item was originally discussed and objected to the large increase of 80% in salary.

Councilmember Obagi reported this is the first increase since 2007 and believed that by raising the City Council salary, the City will get more and better City Council candidates.

Councilmember Loewenstein explained the City is trying to attract people to serve as City Councilmembers; noted the increases will impact certain Councilmembers in 2023 and others in 2024 and none of the current Councilmembers will benefit from it; reported it does not involve a large amount of money; commented on the

subsidy given to the Chamber of Commerce and stated he believes this is the right thing to do.

Councilmember Emdee suggested people will be attracted to City Council positions by Council not playing hate games and having people's reputations dragged through the mud, unnecessarily. She added that she does not object to increasing salaries, but objects to increasing it so much and so quickly.

Mayor Pro Tem Nehrenheim commented on a personal lawsuit waged against him; disagreed with Councilmember Emdee's comments regarding City Council being the highest paid in the area; spoke about the cell phone allowance; discussed Councilmember Horvath's use of a private email service to handle City business and felt decision-makers should be paid for the time taken away from family and friends.

Councilmember Horvath explained his use of a private service noting the City only has a 30-day retention policy.

Mayor Pro Tem Nehrenheim agreed the City's retention policy should be much more than thirty days and supported paying a professional wage for professional services.

Mayor Pro Tem Nehrenheim invited public comments on this item.

Candice Nafissi, via Zoom, spoke in support of the pay increase for City Council; noted Redondo Beach is a unique city; reported everyone on the dais spends more than twenty-five hours a week on City business; stated no one does the job for the money, but felt the increase changes the game and indicated Councilmembers do not give themselves enough credit.

Chief Deputy City Clerk Vickie Kroneberger, via Zoom, read an eComment submitted by Jill Klausen.

Carissa Gallardo felt City Council is under-compensated; noted the raise does not involve a lot of money and supported the increase.

There were no other public comments.

Councilmember Loewenstein noted the request is for a substantial increase and asked for an explanation.

Community Development Director Brandy Forbes reported the biggest impact was the City's Housing Element; noted the City had to look at rezoning and changing land uses; indicated there were several additional community meetings needed to discuss the matter as well as doing a build-out analysis as it had to revise the Housing Element multiple times. Additionally, there were new regulations regarding CEQA which the City had to review and noted there is still the need for a level-of-service evaluation.

Discussion followed regarding the work done outside of GPAC meetings.

Councilmember Loewenstein commended Ms. Forbes, Placeworks and GPAC members for their work and commented on the need to wrap up the work.

Community Development Director Forbes reported there will be one more GPAC meeting, one more community meeting and meetings of the Planning Commission and City Council.

There were no public comments on this item.

J. PUBLIC PARTICIPATION ON NON-AGENDA ITEMS

J.1. For eComments and Emails Received from the Public

John Mann spoke about the proposed dog park at Czuleger Park and asked for additional time so that all voices can be heard.

Joan Irvine, District 1, spoke about volunteering; commented on the cannabis initiative; apologized to Allen Sanford about comments made regarding the recent Beach Life Ranch event related to Catalyst having a booth at the event promoting the initiative; noted Catalyst signed up as the Economic Development Reform of Manhattan Beach and reported Mr. Sanford immediately shut them down when he found out who they were.

Anthony, District 1, agreed with Mr. Mann's comments and asked for additional time so that both those who are against it and those who are for it have an opportunity to have their voices heard.

Holly Osborne, District 5, spoke about SB 1425 regarding the Open Space Element; discussed ADU owners who pave over green space and urged the City to preserve open space.

Wayne Craig spoke about 47 items included in the L.A. County ballot; noted when local initiatives are included in County ballots, people usually do not vote for them; felt City Council wisely separated its initiatives from the County ballot by scheduling a special election and reported the City is saving money by having a special election in October.

Lezlie Campeggi said the reason the City is spending money for a special election is because of one person, Elliott Lewis, who came to the beach cities spending a lot of money trying to control the City's elections and control City laws and urged residents to read the fine print on election materials.

Lina Carrillo, President, Redondo Beach Professional and Supervisory Association, spoke about an item previously considered by City Council relative to a one-time \$20,000 raise to Public Works Employees represented by Teamsters; noted it left out seven Public Works employees that directly supervised the Teamsters employees and asked that City Council reconsider the item and extend the same one-time \$20,000 raise to the group of seven employees.

Rita Horra spoke in opposition to construction of a dog park at Czuleger Park.

Carissa Gallardo urged voters to vote "No" on the recall.

Maggie Healy, via Zoom, said Councilmembers Loewenstein, Obagi and Mayor Pro Tem Nehrenheim violated the Brown Act when they changed agenda items late at night and voted, without notice to the public, specifically related to the special election; that the intent was to confuse the recall with the cannabis issue and take advantage of low voter turnout; that residents should have been noticed and given an opportunity to comment; referenced an open letter from the League of Women Voters rebuking Council's actions and another letter from the Fraud and Corruption Bureau of the Los Angeles District Attorney claiming that Council violated the spirit of the Brown Act; discussed Council's prior action to increase Council salaries and that this is how corruption begins in City government.

Candice Nafissi, via Zoom, urged the public to not be fooled by the information Elliott Lewis is sending to Redondo Beach residents; asked that voters vote "No" on Measure E; requested that Council have increased interactions with Metro and County Supervisors regarding the Green Line and that Council consider sending a letter on behalf of the City and announced that Beryl Elementary School will hold a Trunk or Treat event on October 30, 2022 and the Second Annual Spooktacular event hosted by the 500/600 Block of North Paulina.

Nancy Skiba, District 4, via Zoom, reported Elliott Lewis was recently knocking on Redondo Beach residents' doors asking young people to vote in support of Measure E; spoke about libelous personal attacks and defamation of Councilmember Obagi and urged residents to vote against Measure E and against the recall.

City Clerk Manzano read eComments from Michael Sachs and Nikki Negrete-Mitchell.

There were no other public comments on this item.

City Council skipped to Item No. N.1. of the agenda.

Mayor Pro Tem Nehrenheim reported speaking with the City Manager and members of the public.

Motion by Councilmember Horvath, seconded by Councilmember Loewenstein, to open the public hearing. There being no objections, Mayor Pro Tem Nehrenheim so ordered.

Community Development Director Forbes introduced the item and deferred to Associate Planner Stacey Kinsella for a report.

Associate Planner Kinsella narrated a PowerPoint presentation with details of the Administrative Report.

Mayor Pro Tem Nehrenheim invited public comments.

Charles Spence, Appellant, referenced a report about the property; reported the house is not structurally complete; noted it is not a Craftsman house as it was built in 1933; stated the outside rock is no complete and not part of the original architecture; spoke about a financial hardship; indicated the inside of the house has been rebuilt; that the house is not a historical resource and believed this is an uncompensated taking of the property. Additionally, he confirmed the house did not serve as a religious center and is located on two lots; noted the female engineer referenced did not contribute anything to the field; explained the house caught fire in 1983; stated the ordinance is vague and urged City Council to approve its removal from the historic resource list.

Discussion followed regarding the cost of the GPA report, the process for getting properties on the historic resources list, existing zoning, documentation of how the house was placed on the list of historic resources, the lack of significance in terms of people who lived in the house and plans for the house if it is removed from the historic resources list.

Discussion continued regarding restoration of historical resources, other properties that were taken off the historical resources list, findings made by the Preservation Commission and acknowledging that GPA is the subject expert.

Wayne Craig shared a similar case regarding his sister's house being designated a historic resource without a lot of research and were unable to sell the property without going through the process of removing it from the historic resources list.

Chief Deputy City Clerk Kroneberger, via Zoom, read eComments submitted by Amir Osterweil and Michael Sachs.

There were no other public comments.

Mr. Spence noted that the rocks do not make the structure a historic resource and stated the rocks were added in 1945.

Motion by Councilmember Horvath, seconded by Councilmember Obagi, to close the public hearing. The motion carried 4-0, with the following roll call vote:

Motion by Mayor Pro Tem Nehrenheim, seconded by Councilmember Obagi, to deny the appeal, uphold the Preservation Commission's decision and direct staff to return to City Council with a review and update to the Municipal Code, specifically, 4.403 and 10-4.404.

Councilmember Horvath referenced the GPA report and its findings.

City Clerk Manzano presented details of the Administrative Report and reported she and the City Attorney agree that due to liability they do not recommend approval of the engagement letter with the investigator.

City Attorney Michael Webb added that the investigator will not accept the City's normal indemnity language, he recommends not engaging them.

Mayor Pro Tem Nehrenheim spoke about practices in other cities and saw no issue with keeping the light investigation in-house and signing an agreement with an outside firm.

City Attorney Webb stated that it is wrong for misdemeanors to have a prosecutor conduct interviews in a case they are prosecuting and noted the League of California Cities has determined that appointed city attorneys should not prosecute council members.

City Attorney Webb reported his office will prosecute but cannot do enforcement for criminal matters.

Councilmember Obagi provided a reminder that there has been a hearing on this subject with debates by Mayor Pro Tem Nehrenheim and City Attorney Webb so that another debate is unnecessary.

In response to Councilmember Obagi, City Attorney Webb explained the process for civil cases versus criminal cases and whether the city attorney is appointed versus elected. He added that City Council has no role in the prosecution of criminal matters and noted there is a potential for City Council passing a law and it not being enforced.

Councilmember Obagi spoke in support of having the City Attorney hiring another law firm to conduct investigations.

City Attorney Webb discussed different options available for Council to consider.

There were no public comments on this item.

Public Works Director Ted Semaan introduced the item and deferred to City Engineer Andy Winje for a report.

City Engineer Winje narrated a PowerPoint presentation with details of a request to consider all way stop (AWS) signs at eight intersections within Council District 4 and recommendations.

Councilmember Obagi reported that after the analysis did not meet the requisite level of resident support, an email was sent to residents who had requested stop signs to let them know seven of the eight intersections did not pass under the pre-approved flowchart; noted that the letter did not inform residents that if did not respond to the letter, their lack of response would be deemed a "no" vote and therefore, no action would be taken on it and referenced recommendations as to how the letter could be revised.

Mayor Pro Tem Nehrenheim opened public comments.

Hai Tran referenced eComments he submitted; stated he lives within 150 feet of the intersection of Huntington and Green; reported neither he nor his neighbor received a survey; noted that because of an existing fence, turning on that intersection is challenging; voiced support for the AWS at Huntington; commented on children walking to and from Adams Middle School and urged City Council to consider AWSs at other identified intersections.

Candice Nafissi, via Zoom, spoke about Public Works focusing on numbers; stated she had a similar situation on Paulina; urged the City to focus on what residents are saying and spoke in support of adding AWS at all proposed intersections.

Chief Deputy City Clerk Kroneberger, via Zoom, read eComments submitted by Victoria Nguyen, Nathan Grigg, Brian Luna and Molly Kasch.

Discussion followed regarding Public Works focusing on empirical, subjective metrics to analyze whether an intersection is safe or not, making it safer for children to walk to school and resident support for AWSs.

Motion by Councilmember Obagi, seconded by Councilmember Loewenstein, to install all way stop signs at all identified intersections including Steinhart and Clark.

Councilmember Horvath requested voting on each intersection, individually, noting no complaints in specific intersections near his residence.

Amy Brasil, via Zoom, commented on stop signs on Mathews Avenue at Felton and Perkins; noted there are many children riding eBikes through the intersections and supported placing AWSs at those intersections.

Public Works Director Semaan noted the item was noticed for eight specific intersections; reported the intersection of Clark and Steinhart was not included and therefore, Council may not act on that intersection.

City Manager Witzansky stated if Council is interested in looking at the intersection of Clark and Steinhart, it may direct staff to do so and return with a report at a future Council meeting.

Discussion followed regarding no responses to the survey counting as "no", ensuring the majority of the neighborhood support AWSs, the possibility of lowering the response rate percentage and the possibility of reevaluating poll responses.

Kabir Yadav, via Zoom, reported he lives on Clark Lane; noted increased traffic and the need for AWSs; stated he never received correspondence regarding this matter and neither have his neighbors; and noted negative impacts due to new construction in the area.

There were no other public comments.

Councilmember Obagi commented on what is good for the whole and hoped for increased police enforcement in the future.

Councilmember Emdee suggested considering the increased use of bicycles.

Motion by Councilmember Obagi, seconded by Councilmember Loewenstein, to install all way stop signs at all eight identified intersections and direct Public Works to review the feasibility of installing an AWS at the intersection of Clark and Steinhart and reconsideration of the statistical standard policy as well as provide a copy of the letter that was sent to residents. The motion carried 4-0, with the following roll call vote:

Joan Irvine, District 1, spoke in support of legalizing cannabis and local control; reported she read statements from Catalyst, regarding Measure E and regarding the City's ordinance and State requirements, compared them and offered to submit copies of her research.

Motion by Councilmember Horvath, seconded by Councilmember Loewenstein, to receive and file Ms. Irvine's documents. There being no objections, Mayor Pro Tem Nehrenheim so ordered.

Jonatan Cvetko spoke about Mr. Lewis accepting to debate him and reported he later changed his mind and referenced articles opposing Measure E. He added that Mr. Lewis does not care about the community and thanked City Council for its leadership.

Lezlie Campeggi urged City Council to officially oppose Measure E and commented on the City's ordinance coming into effect on October 6, 2022.

Wayne Craig spoke about the independent statement on the ballot not referencing the City's ordinance as it was not yet in effect, adding that Councilmember Emdee's opposition and statement that it was not time yet for a cannabis ordinance jeopardized the passing of the ordinance and created a bigger problem for the City.

City Attorney Webb spoke about the language City Council chose for the ballot question and felt it could be a source of a greater misunderstanding and suggested Council may want to point out that since then, the City has an ordinance that will go into effect in thirty days.

Rolf Strutzenberg, author of the ballot statement opposing Measure E and the rebuttal to the statement in favor of Measure E, discussed the statements; suggested adding information to the City's website and increased personal outreach and reported the rebuttal was handicapped by the delay in putting the City ordinance into effect.

Councilmember Emdee referenced an eComment submitted by James Crawford as slanderous, false, and was created by Wayne Craig to redirect to Catalyst. She stated nothing in the website referenced is true, it is not hers, and she does not know who this person is.

Chief Deputy City Clerk Kroneberger, via Zoom, read an eComment submitted by James Crawford.

There were no other public comments.

Councilmember Obagi reported that the City Council declined, 5-0, to adopt the initiative as its law and thanked Mr. Strutzenberg for authoring the ballot statement opposing Measure E and the rebuttal to the statement for Measure E.

Motion by Councilmember Horvath, seconded by Councilmember Loewenstein, to OPPOSE MEASURE E, A CITYWIDE BALLOT INITIATIVE BEING CONSIDERED BY VOTERS IN THE CITY'S OCTOBER 19, 2022 SPECIAL ELECTION TO ADOPT A NEW CANNABIS REGULATION ORDINANCE and direct staff to develop FAQs regarding the City's cannabis ordinance and include it on the City's website. The motion passed by unanimous oral vote.
