

RESOLUTION NO. CC-2309-096

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A 2023-2024 FISCAL YEAR BUDGET MODIFICATION TO APPROPRIATE \$51,244 FROM THE EMERGENCY COMMUNICATIONS FUND TO THE POLICE DEPARTMENT 2023-2024 FISCAL YEAR OPERATING BUDGET TO FUND THE PURCHASE OF A REPLACEMENT DIGITAL VOICE RECORDING SYSTEM

WHEREAS, it is the intention of the City Council of the City of Redondo Beach (“City Council”) to review the adopted budget from time to time;

WHEREAS, the City of Redondo Beach’s (“City”) adopted budget needs to be modified to appropriate monies from City funds to fund necessary expenditures;

WHEREAS, the City has established an Emergency Communications Fund to save for the replacement costs of technology used for emergency purposes;

WHEREAS, the current digital voice recording system for the City’s dispatch center has reached its end of useful life, thereby necessitating a new system; and

WHEREAS, the City has available monies in the Emergency Communications Fund to purchase a replacement of the digital voice recording system.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The amounts allocated in the budget for Fiscal Year 2023-2024, and the amounts required to meet conditions which have arisen during the budget year, require a modification in the budget appropriations; and, upon recommendation of the City Manager, the budget appropriation as adopted for Fiscal Year 2023-2024 is modified as follows:

\$51,244 from the Emergency Communications Fund shall be appropriated to the Police Department 2023-2024 Fiscal Year operating budget, Communications Division, Special Departmental Supplies account.

SECTION 2. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.

SECTION 3. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2023-2024 in accordance with the above modification.

SECTION 4. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
