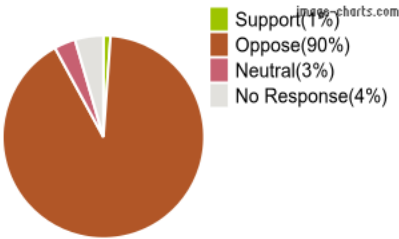

Overall Sentiment



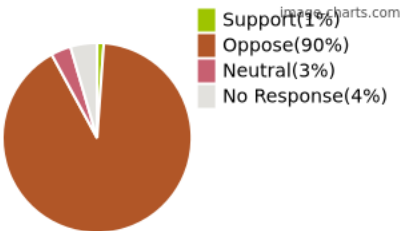

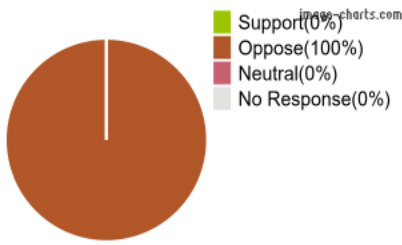
Overall Sentiment

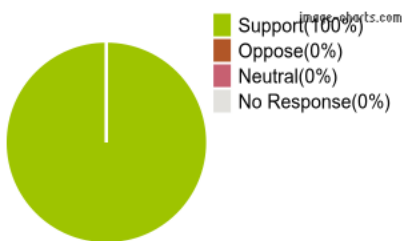

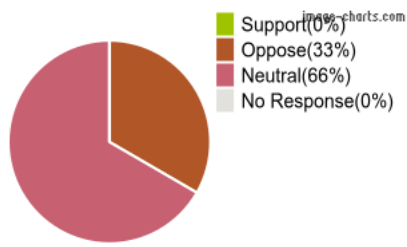

Keep hearing that a kid should be able to draw it. Pretty sure a kid could handle the current logo.

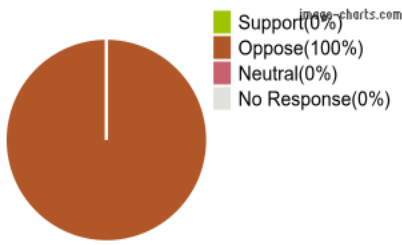

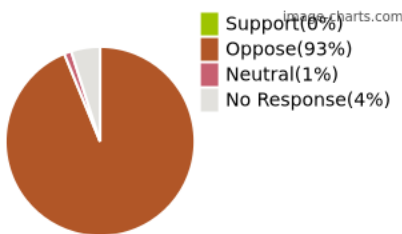

He currently and worked for the LACFD for over 28 years. He is a lifeguard and has held other various positions with the LACFD. According to a Gov't Code #18701: " "A Public official has a financial interest in any source, whether an individual or an organization, from whom the official has received (or from whom the official has been promised) \$500 or more in income within 12 months prior to the decision about which the official is concerned". I find it hard to imagine that Nils Nehrenheim is paid less than \$500 per year from the LACFD. I've asked the City Attorney to request CM Nehrenheim's past two years of W-2 and 2024 paystubs. This is the law. It doesn't matter what position he holds with the LACFD, he is paid by them and it's against the law. I'm sure when CM Nehrenheim originally said he had no financial interest in the LACFD, he didn't know about a this code that prohibits him from discussing this issue on the city council.

With the conclusion of Citygate Associates LLC's analysis that examined the pros and cons of turning over to Los Angeles County Fire Department (LACFD), the Redondo Beach Fire Department's (RBFD) responsibilities,

services and equipment; there is no doubt that any short term benefit gained by cutting services to residents, is outweighed by expensive and without limit, long term costs. In every case in which cities have 'gone County', increasing costs for the services provided has occurred, even while service levels decreased.

Also beyond doubt is that RBFD would be of great benefit to LACFD, as it would be the proud owner of all equipment bought and paid for by RBFD, including the recently purchased \$1MM Seagrave Capitol Fire Engine #62. LACFD would also benefit from the acquisition of fire personnel - all certified EMTs. Most of the calls RBFD receives and responds to are medical emergencies, and RBFD's quick response times and immediate medical attention are often the difference between life and death. There is no guarantee that LACFD will have these personnel available whenever Redondo residents make the call.

Putting aside the cost/benefit factors, one thing stands out as a primary reason we must keep our fire department local: ISO ratings. ISO is an agency that "collects information on a community's public fire protection"... . RBFD has a Class 1 rating, while LACFD has either a Class 2 or 3 rating, which varies based on the many communities in its' service area.
