Dear Board members,

As we get closer to the C-Line Extension route recommendation, more misinformation is being circulated as well as accusations of personal biases. This kind of communication coming from Board members does not help to inform our cities. Instead, it just creates division. With this letter, as the SBCCOG officers, we want to clarify that the SBCCOG's role in dealing with regional issues is to remain neutral.

First and foremost, the SBCCOG as a member organization has not taken positions on issues in which the members disagree. The SBCCOG plays a valuable role in providing information on issues of importance to cities so that cities can decide on their position. If there is consensus among the South Bay cities, then the SBCCOG is able to speak for the group as a whole.

In as much, this policy was affirmed at the last City Managers Working Group where they opined that the SBCCOG should take no position on the C-Line Extension issue because the members had conflicting positions. The SBCCOG Transportation Committee has also discussed the issue at several meetings and received briefings but recent meetings have been cancelled due to no new information.

Moreover, the C-Line decision will be made by Metro and the SBCCOG has no special standing to influence Metro's decision. Any and all advocacy should be focused on Metro. Let's remember that the strength of the SBCCOG is representing our cities when they are united in their advocacy. That is not the case with the C-Line extension and on behalf of the Executive Board we hope this helps in clarifying the situation.
