Staff recommends that the Commission nominate and select a Chairperson, Vice Chairperson, and Secretary.

BACKGROUND

Elections of Officers for the City's commissions are conducted annually at the regularly scheduled October Commission meeting or at the next available commission meeting as per the City's Municipal Code. Any member of the commission may serve as Chairperson, Vice Chairperson and Secretary and there is no limit to the number of terms a Commissioner may serve for each role. The term of service is for approximately one year or until the annual Election of Officers is held.

The Chairperson serves to oversee the commission's regular meetings and maintains the flow of the agenda and the decorum of the meeting. The Chairperson remains a voting member of the commission. The Vice Chairperson fills in for the Chairperson in their absence. The role of Secretary is ceremonial. Staff will continue to facilitate meeting minutes and other administrative responsibilities required of the commission.

CONSIDERATION OF THE APPOINTMENT OF MATTHEW MCCAULEY TO THE AD HOC SUBCOMMITTEE

BACKGROUND

The Redondo Beach Municipal Code (RBMC) outlines the policies and procedures that govern the Youth Commission, including its Ad Hoc Subcommittee (AHS). RBMC § 2-9.603 provides the Youth Commission with the authority to appoint members to its AHS, which serves as an extension of the commission. Members must be between the ages of 12 and 19 and serve a participatory role in all facets of the commission excluding voting rights. They are encouraged to participate in discussions, serve on any subcommittees developed by the commission, and volunteer at events or activities. The purpose of the AHS is to be a launching point for those interested in becoming a Youth Commissioner with voting capabilities, considering the requirement to serve on the AHS for a year prior to appointment to the commission. Since the commission was just recently reformed, appointments to the AHS were made by the Mayor and City Council and commission members were not required to serve on the AHS prior.

Staff recently received notification that Matthew McCauley would like the commission to consider his appointment to the AHS for the 2024-25 term. Matthew is currently a senior at Redondo Union High School (RUHS) and considers mental health and traffic safety as two issues that he would like to assist the commission in reaching out to local youth about. He believes the greatest need for teens in the South Bay are safety, substance abuse awareness, and E-bikes. He is involved in extra-curricular sports at RUHS and founded a nonprofit youth program that organizes baseball games for those with special needs or physical challenges.

Currently, the AHS has three members. The RBMC does not note a limit to the number of members, so the addition of Matthew McCauley would be permitted.

Staff recommends the commission consider Matthew's interest in serving on the AHS and determine whether it would like to appoint him to this role for the 2024-25 term.

BACKGROUND

2024-25 Projects and Focus Areas

The Redondo Beach Municipal Code (RBMC) outlines the roles and responsibilities of the Youth Commission (Commission). Specifically, RBMC § 2-9.602 includes the following roles and purposes:

- a) Identify and report to the City Council annually on the youth needs and priorities of Redondo Beach
- b) Remain informed on the programs providing youth services to Redondo Beach (annual review)
- c) Research, formulate, suggest proposed policies, programs and services designed to meet the needs of Redondo Beach youth
- d) Review and evaluate requests received by the City pertaining to its youth-related policies/services
- e) Maintain liaison with the Youth Commissions in other cities, and/or youth-related agencies
- f) Represent the City of Redondo beach when requested to do so

At the Commission's October 3 meeting, it received a report that outlined previous agenda topics discussed by the commission in 2020 and 2021 including COVID policies, mental health awareness, drug use, and the AES Power Plant. Additionally, staff provided critical topics received from the commissioners during the interview process that were identified as current issues or projects that would support the City's teens, including:

- Barriers to socialization
- E-bikes
- Mental health
- Drug use
- General safety
- Nutrition and obesity
- Creation of a social media presence that caters to the City's teens
- Development of a teen survey to gather data on issues, areas of improvement, event ideas, potential collaborations, etc.
- · Creation of teen and family event nights
- Creation of a comprehensive activities calendar
- Development of a one-stop shop for teen resources
- Creation of a streamlined way to communicate with teens via text or social media

Teen Center Subcommittee

The City plans to reopen its Teen Center at Perry Park in early 2025. As part of this reopening, staff will rely heavily on the Commission to assist in the development of programs, activities, events, and resources that would take place at the facility. Therefore, staff recommends the Commission develop a Teen Center Subcommittee to work closely with staff and to provide regular updates to the Commission on the progress of the facility.

Safety and Access at Redondo Union High School (RUHS)

Staff are beginning to work with consultants and the community to redesign areas adjacent to RUHS that aim to improve safety and access to campus. The specific focus area will include Diamond Street with consideration for improvements along El Redondo/Vincent Park area. The final product will include design plans for the restriping of these critical roads to enhance safety and access. A component of this project will include virtual stakeholder engagement sessions and are limited to key demographics related to the project. These meetings are anticipated to take place in December and January.

Staff requests the Commission appoint two commissioners that could participate in these discussions and confidently speak on their experiences and those of other teens accessing campus. It is desired that one representative be someone who primarily drives to school and the second one bikes or walks to campus. This will help ensure that the session includes a wide variety of experiences and viewpoints.

Staff recommends that the Commission:

- 1. Determine a prioritized list of projects and critical focus areas for the 2024-25 term and, where possible, determine any subcommittees needed to accomplish the goals of the Commission
- 2. Create a Teen Center Subcommittee to assist staff in the reopening of the facility and to provide regular updates to the Commission on any reopening or programmatic information
- 3. Appoint two commissioners to represent the Commission during stakeholder sessions regarding safety and access at Redondo Union High School.
