FIRST AMENDMENT TO AGREEMENT FOR CONSULTING SERVICES BETWEEN THE CITY OF REDONDO BEACH AND BUREAU VERITAS NORTH AMERICA, INC.

THIS FIRST AMENDMENT TO THE AGREEMENT FOR CONSULTING SERVICES ("First Amendment") is made between the City of Redondo Beach, a chartered municipal corporation ("City") and Bureau Veritas North America, Inc., a Delaware corporation ("Consultant").

WHEREAS, on February 9, 2021, the parties hereto originally entered into that certain Agreement for Consulting Services between the City and Consultant ("Agreement"); and

WHEREAS, City and Consultant desire to amend the Agreement pursuant to the terms and conditions set forth herein.

NOW, THEREFORE, the parties hereby agree to make the following amendments to the Agreement:

- 1. <u>Scope of Services</u>. Exhibit A is amended to include the following: Consultant shall provide plan review services for the City of Redondo Beach Galleria Tennant Improvement Project. The plan review services include the first review plus two rechecks with the initial review being completed within 15 working days of receiving approval and associated documents.
- 2. <u>Compensation</u>. Exhibit C is amended to provide compensation in a not-toexceed amount of \$55,000.00 for the plan review services for the City of Redondo Beach Galleria Tennant Improvement Project.

The fee schedule above shall be the rates for any subsequent reviews and/or extra service work for the duration of the project.

3. <u>Modification.</u> Except as expressly set forth herein, the Agreement shall continue in full force and effect. The Agreement together with this First Amendment constitutes the entire agreement between the parties and supersedes any previous oral or written agreement. In the event of any inconsistency between this First Amendment and the Agreement the terms of this First Amendment shall prevail. This First Amendment may be modified or amended only by a subsequent writing executed by all of the parties.
