Hello Everyone!

Now that the fire study has concluded, we can see that though short term there may be some cost savings due to cutting services, in the long term, this will be more expensive for Redondo Beach as there are no limitation to what county will charge us in the future for services. County has indeed passed increases to the various cities they represent over the years, so we know they have this precedence of increasing costs which the cities must absorb. Additionally, it's not a cost saving even short term if we are getting less services. Pay more to get less? Absolutely not. Based on this, we must keep our RBFD local.

RBFD provides excellent service to the residents. We benefit from having 100% of the care and attention of RBFD. We will not have this benefit when we have to share LACountyFire with everyone else. LA County WILL NOT prioritize Redondo in case of a disaster.

Most of the calls RBFD responds to are medical emergencies, not fires. They respond within moments, not minutes. This quick response time is the difference between life and death.

You have a moral responsibility to do what's best for the city. I can understand that some of you may feel beholden to the fire union for their support in various campaigns, but ultimately, you are only beholden to the residents you represent. With elections coming up in 2025, residents will be using their voting power to determine who will lead this city. If you vote to send our local fire department to County, there is no doubt that will be an act of political suicide.

We have 53 e-comments as of 9:40am on 4/16/2024 all opposing having our 100 year old Class 1 fire department going to County which is NOT Class 1. All of Redondo Beach from North to South is saying the same thing. I'm asking you do as the people demand and vote to KEEP OUR FIRE DEPARTMENT LOCAL.
