## **RESOLUTION NO.CC-2512-096**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, TO DESIGNATE THREE OFFICIAL LOCATIONS FOR THE POSTING OF ORDINANCES AND OTHER LEGAL NOTICES PERTAINING TO MUNICIPAL AFFAIRS OF THE CITY, TO SATISFY PUBLICATION REQUIREMENTS UNDER MEASURE CAP RELATED TO CHARTER AMENDMENTS ARTICLE IX, SECTION 9.15; ARTICLE XVII, SECTION 17.9; AND ARTICLE XIX, SECTIONS 19 AND 19.5

WHEREAS, Measure CAP was duly approved by the voters of the City of Redondo Beach ("City"), California, on Tuesday, March 4, 2025, receiving 84.63% of the vote, thereby amending the City Charter;

WHEREAS, prior to the passage of Measure CAP, the City Charter required that legal notices to be published in the City's official newspaper;

WHEREAS, Measure CAP amended City Charter Sections 9.15, 17.9, 19, and 19.5 to revise the procedures for publishing legal notices related to Ordinances, Budget Hearings, Public Contracts, and other matters requiring public notification; and

WHEREAS, for matters solely concerning municipal affairs, the amended City Charter authorize alternative publication methods, including posting notices in three public places and on the City's official website, in lieu of publication in the official newspaper.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby designates the following primary locations for the posting of ordinances and other legal notices pursuant to the alternative publication methods authorized under the City of Redondo Beach Charter Article IX, Section 9.15 (Ordinances, publication); Article XVII Section 17.9 (Budget hearing and adoption); Article XIX Sections 19 (Public Works, contacts), and 19.5 (Legal notices, contract for publication), for matters solely pertaining to municipal affairs of the City:

- City Hall Bulletin Board 415 Diamond Street, Redondo Beach, CA 90277
- Alta Vista Park & Community Center 715 Julia Avenue, Redondo Beach, CA 90277

SECTION 2. This resolution shall take effect immediately upon its adoption by the City Council.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
