Re: Redondo Beach Unified School District Board of Education's Recommendation
Regarding City Charter Amendments

Dear Mayor Light and Members of the Redondo Beach City Council:

I am writing to inform you of a change in the perspective of the Board of Education (the "Board") of the Redondo Beach Unified School District ("RBUSD") regarding a specific provision within the City Charter.

The Board's review of this matter was prompted by the City Council's deliberations at its May 7, 2024 meeting. Upon further consideration, the Board recommends that the City initiate the process of putting a measure on the November 2024 ballot that would amend Section 16.1 of the City Charter to delete the following language: "without compensation, except necessary expenses when acting as a designated representative of the Board of Education as provided in the Education Code of the State of California."

The Board reached this recommendation at a regularly scheduled meeting on May 16 and May 28, 2024. It arises from an acknowledgment that the California Education Code and the California Government Code aptly regulate the issue of school board compensation. These statutes provide a standardized framework for offering modest remuneration to Board members, including provisions for necessary expense reimbursements.

The language in question, a relic of the 1940s, is at odds with the current statutes of California's Education Code and Government Code. This misalignment has sown confusion and ambiguity regarding the application of compensation and expense reimbursement for the RBUSD Board members. By removing this outdated language, we aim to harmonize our practices with those of nearly every other school district in the state, promoting equity and clarity in our governance structure.



However, offering a modest compensation to Board members may broaden the pool of candidates seeking office, fostering greater diversity and inclusivity within our ranks. We believe that providing nominal compensation acknowledges the significant responsibilities shouldered by school board members and ensures that individuals from all economic backgrounds have the opportunity to contribute to our community. This aligns with our overarching goal of maintaining a Board that reflects the diverse perspectives and experiences within the Redondo Beach community.

Thank you for the opportunity to be part of the City Charter Review process. The Board looks forward to working collaboratively with the City Council to advance this proposed amendment to a vote of the electorate for the betterment of our district.
