

RESOLUTION NO. CC-2607-056

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL YEAR 2026-2027 BUDGET MODIFICATION TO APPROPRIATE \$198,126 IN PERMANENT LOCAL HOUSING ALLOCATION FUNDS FROM THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT TO THE INTERGOVERNMENTAL GRANT FUND

WHEREAS, it is the intention of the City Council of the City of Redondo Beach ("City Council") to review the adopted budget from time to time; and

WHEREAS, the City of Redondo Beach's adopted budget needs to be modified to appropriate monies to fund necessary expenditures; and

WHEREAS, in September 2017, the California Legislature approved Senate Bill 2 (SB 2), known as the Building Homes and Jobs Act, establishing the Permanent Local Housing Allocation (PLHA) as a permanent source of funding for housing related issues; and

WHEREAS, on December 13, 2022, City Council held a public hearing and adopted the City's Five-Year PLHA Plan and resolution to apply for the grant; and

WHEREAS, on February 15, 2023, the California Department of Housing and Community Development (HCD) awarded the City PLHA appropriations for Calendar Years 2019, 2020 and 2021 in the amount of \$557,962 for the City's Pallet Shelter; and

WHEREAS, on June 13, 2023, the City entered into an agreement with the Department of Housing and Community Development to accept the award; and

WHEREAS, on October 17, 2023, City Council adopted Resolution No. CC-2310-107 authorizing a 2023-2023 budget modification to appropriate \$557,962 in PLHA funds for calendar years 2019-2021; and

WHEREAS, HCD has allocated Redondo Beach \$112,160 for Calendar Year 2022 and \$85,966 for Calendar Year 2023 for a total of \$198,126; and

WHEREAS, request for funds applications will be submitted to HCD in order to receive funding for calendar years 2022-2023, totaling \$198,126; and

WHEREAS, the City has approved the receipt and appropriation of past funding for similar programs.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the amounts allocated in the budget of Fiscal Year 2026-2027 and the amounts required to meet conditions which have arisen during the budget year require a modification in the budget appropriation; and, upon recommendation of the City Manager, the budget appropriation as adopted for Fiscal Year 2026-2027 is modified as follows:

One hundred ninety-eight thousand one hundred twenty-six (\$198,126) in PLHA funds from the California State Department of Housing and Community Development shall be appropriated to the Intergovernmental Grant Fund and expended for the Redondo Beach Pallet Shelter.

SECTION 2. That pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed and instructed to correct the budget records of said City for Fiscal Year 2026-2027 in accordance with the above modification.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
