

RESOLUTION NO. CC-2604-020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, ACCEPTING A DONATION IN THE AMOUNT OF \$20,308.16 FROM THE REDONDO BEACH POLICE AND FIRE FOUNDATION AND AUTHORIZING A FISCAL YEAR 2025–2026 BUDGET MODIFICATION TO APPROPRIATE THE \$20,308.16 IN DONATION FUNDS TO THE FIRE DEPARTMENT OPERATING BUDGET TO PARTIALLY FUND THE COST OF FOUR (4) SEEK PRO+ THERMAL IMAGING CAMERAS

WHEREAS, it is the intention of the City Council of the City of Redondo Beach (“City Council”) to review the adopted budget from time to time; and

WHEREAS, the City Fire Department applied for and received a donation from the Redondo Beach Police and Fire Foundation (“RBPAFF”) to purchase new SEEK PRO+ thermal imaging cameras using the latest technologies; and

WHEREAS, the City Fire Department received notification of the donation award following finalization of the FY 2025-26 Adopted Budget; and

WHEREAS, from Redondo Beach Police and Fire Foundation has provided a donation in the amount of Twenty Thousand Three Hundred Eight Dollars and Sixteen Cents (\$20,308.16) to purchase four (4) new SEEK PRO+ thermal imaging cameras using the latest technologies; and

WHEREAS, in accordance with the Donation Policy, the City desires to accept the donation and authorize a budget modification to appropriate the funds.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the City Council hereby accepts a donation in the amount of Twenty Thousand Three Hundred Eight Dollars and Sixteen Cents (\$20,308.16) from the Redondo Beach Police and Fire Foundation in accordance with the City’s Donation Policy adopted on October 4, 2016, for the stated public purpose of purchasing four (4) SEEK PRO+ thermal imaging cameras.

SECTION 2. That conditions have arisen during the 2025-2026 budget year that require budget modifications and, upon recommendation of the City Manager, the budget as adopted for Fiscal Year 2025-2026 is modified as follows:

Twenty Thousand Three Hundred Eight Dollars and Sixteen Cents (\$20,308.16) is hereby appropriated to the Fire Department's 2025–2026 Fiscal Year Operating Budget, Training Contracts/Professional Services Account reflecting funding received from the Redondo Beach Police and Fire Foundation.

SECTION 3. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2025-2026 in accordance with the above modification.

SECTION 4. This resolution shall take effect immediately upon its adoption by the City Council.

SECTION 5. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
