A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A 2025-2026 FISCAL YEAR BUDGET MODIFICATION TO APPROPRIATE \$34,750 OF UNALLOCATED GENERAL FUND BALANCE TO THE CITY MANAGER'S OFFICE CONTRACTS AND PROFESSIONAL SERVICE BUDGET

WHEREAS, it is the intention of the City Council of the City of Redondo Beach ("City Council") to review the adopted budget from time to time; and

WHEREAS, On July 1, 2025, the City Council voted to conduct a community survey regarding the City's Commercial Retail Cannabis Regulatory Program and the possible issuance of permit applications; and

WHEREAS, the City received a proposal from Fairbank, Maslin, Maullin, Metz & Associates (FM3) to conduct the survey in an amount not to exceed \$34,750; and

WHEREAS, as part of the approved motion, the Council directed staff to allocate unallocated General Fund balance to cover the cost of the survey; and

WHEREAS, the City's adopted budget needs to be modified to appropriate the funds to cover the cost of the survey.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1: That the amounts allocated in the budget for Fiscal Year 2025-2026 and the amounts required to meet conditions which have arisen during the budget year, require a modification in the budget appropriations; and, upon recommendation of the City Manager, the budget appropriation as adopted for Fiscal Year 2025-2026 is modified as follows:

Appropriate \$34,750 of unallocated General Fund balance to the City Manager's Office Contracts and Professional Services account to the cover the costs of the survey.

SECTION 2: Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2025-2026 in accordance with the above modification.

SECTION 3: That the City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolution.
