

RESOLUTION NO. CC-2604-022

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AWARDED A PUBLIC WORKS CONTRACT TO RAMCO GENERAL ENGINEERING CONTRACTORS, INC., A CALIFORNIA CORPORATION, IN THE AMOUNT OF \$719,885 FOR THE VETERANS PARK HISTORIC LIBRARY AND COMMUNITY CENTER - EXTERIOR ACCESSIBILITY IMPROVEMENTS, JOB NO. 20900

WHEREAS, the Veterans Park Historic Library and Community Center's exterior accessibility in the City of Redondo Beach ("City") is in need of repair and improvement; and

WHEREAS, on March 3, 2026, the City Council of the City of Redondo Beach approved the Plans and Specifications for the Veterans Park Historic Library and Community Center – Exterior Accessibility Improvements Project, Job No. 20900 (the "Project") and authorized the City Clerk to advertise for competitive bids; and

WHEREAS, on April 2, 2026, bids for this Project were received and publicly opened at the City Clerk's Office; and

WHEREAS, RAMCO General Engineering Contractors Inc., a California corporation, is the lowest responsible bidder for this Project, as more particularly described in the Plans and Specifications thereof, and incorporated herein by reference, and is awarded the contract for this Project in the amount of \$719,885; and

WHEREAS, RAMCO General Engineering Contractors Inc. shall provide all applicable insurance certificates and bonds to the City for approval prior to the execution of the contract; and

WHEREAS, sufficient Capital Project Funds have been appropriated for this Project in the adopted FY 2025-2030 Capital Improvements Program Budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council of the City of Redondo Beach, California, awards the contract for the Veterans Park Historic Library and Community Center – Exterior Accessibility Improvements Project, Job No. 20900 to RAMCO General Engineering Contractors Inc. in the amount of \$719,885 on the condition that all applicable insurance certificates and bonds shall be provided to the City for approval prior to the Mayor executing the contract on behalf of the City.

SECTION 2. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
