

**SECOND AMENDMENT TO THE MEMORANDUM OF
UNDERSTANDING BY AND BETWEEN THE REDONDO
BEACH UNIFIED SCHOOL DISTRICT AND THE
CITY OF REDONDO BEACH
REGARDING THE SCHOOL RESOURCE OFFICER PROGRAM**

This Second Amendment to the Memorandum of Understanding by and between the Redondo Beach Unified School District and the City of Redondo Beach regarding the School Resource Officer Program ("Second Amendment") is made between the City of Redondo Beach, a chartered municipal corporation ("City") and the Redondo Beach Unified School District ("District").

WHEREAS, on September 3, 2019, the parties entered into a Memorandum of Understanding regarding the School Resource Officer Program (the "MOU"); and

WHEREAS, on June 15, 2021, the parties entered into the First Amendment to the MOU; and

WHEREAS the parties desire to amend the MOU.

NOW THEREFORE, in consideration of the promises and mutual covenants contained herein, and intending to be legally bound, the parties hereby agree to make the following amendments to the MOU:

1. Term of MOU: Section 1 of the MOU is amended to extend the expiration date from June 30, 2023, to June 30, 2025.
2. Compensation: Section 5 of the MOU will be amended to provide the following:


The District agrees to pay \$100,000 annually to the City for one (1) additional School Resource Officer (SRO), as defined in section 3 of the MOU. The District shall make quarterly payments. Under no circumstances shall the total amount paid by the District exceed \$600,000 under the MOU and any amendments.

3. No Other Amendments. The Agreement, First Amendment, and this Second Amendment constitute the entire agreement between the parties and supersede any previous oral or written agreement with respect to the subject matter hereof. In the event of any inconsistency between the terms of the Agreement, First Amendment, and this Second Amendment, the terms of this Second Amendment shall govern.


