

RESOLUTION NO. CC-2607-049

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AMENDING THE CIVIL PENALTIES FOR PARKING VIOLATIONS REGARDING VIOLATIONS OF PARKING RESTRICTIONS DURING VARIOUS HOURS FOR STREET SWEEPING WHICH SHALL INCREASE THE TOTAL PENALTY AMOUNT FROM \$55 TO \$79

WHEREAS, pursuant to California Vehicle Code Section 40203.5(a) the schedule of parking penalties for parking violations and late payment penalties shall be established by the governing body of the jurisdiction where the notice of violation is issued; and

WHEREAS, pursuant to California Vehicle Code Section 40203.5(a) the City of Redondo Beach ("City") has the authority to establish parking penalties for parking violations, including violations of parking restrictions during various hours for street sweeping in which citations are issued by the City for such violations; and

WHEREAS, the City's civil penalties for parking violations are set by resolution; and

WHEREAS, the current parking penalty for a violation of parking restrictions during various hours for street sweeping is \$42 plus a civil penalty assessment of \$13, pursuant to Government Code Sections 76000(b), 76100, and 70372(b), for a total parking penalty of \$55; and

WHEREAS, the City Council desires to increase the parking penalty for a violation of parking restrictions during various hours for street sweeping to \$66 plus a civil penalty assessment of \$13, pursuant to Government Code Sections 76000(b), 76100, and 70372(b), for a total parking penalty of \$79.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the Redondo Beach City Council hereby amends the civil penalties for parking violations by establishing a parking penalty of \$66, plus a civil penalty assessment of \$13, for a total parking penalty of \$79 for violations of parking restrictions during various hours for street sweeping.

SECTION 2. This amended parking penalty shall be effective July 7th, 2026.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
