

RESOLUTION NO. CC-2605-023

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AWARDING A PUBLIC WORKS CONTRACT TO CALMEX ENGINEERING, INC., A CALIFORNIA CORPORATION, IN THE AMOUNT OF \$3,477,163.25 FOR THE RESIDENTIAL STREET REHABILITATION PROJECT, CYCLE 2, PHASE 5, JOB NO. 40190

WHEREAS, various residential streets within the City of Redondo Beach ("City") are in need of repair and improvement; and

WHEREAS, on September 2, 2025, the City Council of the City of Redondo Beach approved the Plans and Specifications for the Residential Street Rehabilitation Project, Cycle 2, Phase 5, Job No. 40190 (the "Project") and authorized the City Clerk to advertise for competitive bids; and

WHEREAS, on April 8, 2026, bids for this Project were received and publicly opened at the City Clerk's Office; and

WHEREAS, CalMex Engineering, Inc., a California corporation ("CalMex Engineering"), is the lowest responsible bidder for this Project, as more particularly described in the Plans and Specifications thereof, and incorporated herein by reference, and is awarded the contract for this Project in the amount of \$3,477,163.25; and

WHEREAS, CalMex Engineering shall provide all applicable insurance certificates and bonds to the City for approval prior to the execution of the contract; and

WHEREAS, sufficient Capital Project Funds have been appropriated for this Project in the adopted FY 2025-2030 Capital Improvements Program Budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council of the City of Redondo Beach, California, awards the contract for the Residential Street Rehabilitation Project, Cycle 2, Phase 5, Job No. 40190 to CalMex Engineering, Inc. in the amount of \$3,477,163.25 on the condition that all applicable insurance certificates and bonds shall be provided to the City for approval prior to the Mayor executing the contract on behalf of the City.

SECTION 2. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
