A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, APPROVING THE SUSPENSION OF PREFERENTIAL PARKING HOURS IN THE VINCENT AND VINCENT 2 PREFERENTIAL PARKING DISTRICTS FOR LIMITED HOURS ON JUNE 11, AND JUNE 12, 2025

WHEREAS, in 2025, Redondo Union High School, Patricia Dreizler Continuation High School (collectively, the "High Schools"), and Parras Middle School and Adams Middle School (collectively, the "Middle Schools") graduations will take place at Redondo Union High School on June 11th and June 12th respectively; and

WHEREAS, the suspension of the preferential parking hours for the in-person graduation ceremonies for the High Schools and the Middle Schools will occur over two (2) days and are expected to extend only two (2) hours beyond the duration of a typical High School graduation ceremony; and

WHEREAS, the City of Redondo Beach ("City") created the Vincent and Vincent 2 preferential parking districts, which are located near Redondo Union High School; and

WHEREAS, the commencement ceremonies are expected to attract thousands of guests; and

WHEREAS, there is limited parking for these guests at Redondo Union High School; and

WHEREAS, many of the guests are expected to park in the Vincent and Vincent 2 preferential parking districts temporarily which would violate existing preferential parking restrictions in the absence of this resolution; and

WHEREAS, the issuance of parking citations for violations of the Vincent and Vincent 2 preferential parking districts during the commencement ceremonies would not serve the best interests of the community; and

WHEREAS, to accommodate the anticipated increase in parking demand associated with the Middle Schools' and High Schools' commencement ceremonies, the City wishes to temporarily suspend the preferential parking hours in the Vincent and Vincent 2 preferential parking districts from 8:00 A.M. to 6:00 P.M. on June 11, 2025, and from 12:00 P.M. to 6:00 P.M. on June 12, 2025.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That on June 11, 2025 the preferential parking restrictions in the Vincent and Vincent 2 preferential parking districts shall be suspended from 8:00 A.M. to 6:00 P.M.

SECTION 2. That on June 12, 2025 the preferential parking restrictions in the Vincent and Vincent 2 preferential parking districts shall be suspended from 12:00 P.M. to 6:00 P.M.
