

**RESOLUTION NO. CC-2404-025**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
REDONDO BEACH, CALIFORNIA, AUTHORIZING THE  
DONATION OF A POLICE VEHICLE TO THE REDONDO BEACH  
FIREFIGHTER'S ASSOCIATION**

WHEREAS, the City of Redondo Beach ("City") owns a police vehicle, as described in Exhibit "A", that is out of service and no longer required for City operations; and

WHEREAS, the Redondo Beach Firefighters' Association ("RBFA") has demonstrated a need for such a vehicle to participate in the Firefighter Demolition Derby on July 7, 2024, a charitable event that raises funds and awareness for the Burn Institute; and

WHEREAS, the Burn Institute is a nonprofit organization dedicated to fire and burn prevention education, as well as supporting burn survivors through various programs, including Camp Beyond the Scars for burn-injured children; and

WHEREAS, the City desires to donate said vehicle to RBFA to support the Burn Institute's mission.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the City Council of the City of Redondo Beach authorizes the donation of the out of service police vehicle, as described in Exhibit "A" to the Redondo Beach Firefighters' Association for the specific purpose of its use in the Firefighter Demolition Derby to benefit the Burn Institute.

SECTION 2. That the City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
