CHANGE ORDER NO. 4

February 28, 2024

I. Description of Work Included in the Contract:

Saw cutting and removal of asphalt pavement, curb, gutter and sidewalk; construction of concrete sidewalk, driveways, and curb and gutter; construction of asphalt pavement; construction of ADA ramps; construction of sewer system; installation of a traffic control devices and signs; installation of pedestrian related amenities; landscaping and irrigation system; traffic striping and pavement markings; and other work per the project Plans and Specification on Torrance Boulevard between Prospect Avenue and Torrance Circle in the City of Redondo Beach, California.

II. Changes Ordered

This following change have been ordered:

- **Item #1** – Hawthorne Blvd median emergency repairs due to damages caused by recent atmospheric river storm events. The scope of work includes mobilization, stabilization, removal of damaged CMP pipe and manhole structure, construction of a new manhole as per APWA standard 320-2, backfill, and landscape restoration.

III. Reasons for the Changes

- **Item #1** – On February 7, 2024, a severe storm battered Hawthorne Blvd, causing a sinkhole to form in the center median due to partial failure of the city-owned storm drains, requiring critical repairs in order to protect public safety. As the emergency repairs required to fix the sinkhole were beyond the capabilities of the city crew, the staff took charge and solicited three quotes from licensed contractors who already work for the city. After a thorough review of all the proposals, Hardy & Harper stood out, providing the most competitive quote for a lump sum of \$110,000. Their expertise and efficiency make them the best choice for this “off-site improvement”.
