WHEREAS, on June 18, 2024, the City Council of the City of Redondo Beach approved Resolution No. CC-2406-053 appointing a new Mayor Pro Tem, delegates and alternatives as official representatives of the City for a term commencing July 1, 2024 and expiring June 30, 2025; and
