

RESOLUTION NO. CC-2608-060

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL YEAR 2026-2027 BUDGET MODIFICATION TO APPROPRIATE \$7,929.13 IN GRANT FUNDS AWARDED BY THE BUREAU OF JUSTICE ASSISTANCE UNDER THE 2025 PATRICK LEAHY BULLETPROOF VEST PARTNERSHIP PROGRAM TO THE INTERGOVERNMENTAL GRANTS FUND

WHEREAS, it is the intention of the City Council of the City of Redondo Beach ("City Council") to review the adopted budget from time to time; and

WHEREAS, on May 22, 2026, the City of Redondo Beach ("City") was notified that it was awarded funds from the Patrick Leahy Bulletproof Vest Partnership Program ("BVP Program"), administered by the Bureau of Justice Assistance ("BJA"), which is part of the Office of Justice Programs ("OJP") within the U.S. Department of Justice ("DOJ"), in the amount of \$7,929.13 for federal Fiscal Year 2025; and

WHEREAS, the BVP Program provides federal funds to reimburse up to 50% of the cost of bulletproof vests purchased for sworn law enforcement officers including vests for local and tribal law enforcement agencies that enhance officer safety; and

WHEREAS, the BVP Program funds will be made available to the City for the period commencing April 1, 2025 through August 31, 2027; and

WHEREAS, the Redondo Beach Police Department will benefit from the use the awarded funds to offset the cost of bulletproof vests purchased for sworn law enforcement personnel as approved by the BJA; and

WHEREAS, the City Council has approved the receipt and appropriation of past funding for similar police programs; and

WHEREAS, the City's adopted budget for Fiscal Year 2026-2027 will need to be modified to accept and appropriate the awarded funds from the BVP Program for this specific purpose.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the amounts allocated in the budget for Fiscal Year 2026-2027 and the amounts required to meet conditions which have arisen during the budget year, require a modification in the budget appropriations; and, upon recommendation of the

City Manager, the budget appropriation as adopted in Fiscal Year 2026-2027 is modified as follows:

\$7,929.13 in funds awarded by the Bureau of Justice Assistance under the Patrick Leahy Bulletproof Vest Partnership Program shall be appropriated to the Intergovernmental Grants Fund.

SECTION 2. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2026-2027 in accordance with the above modification.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
