1. The Entertainment Permit approved herein shall be valid for a period of 730 days from the date of approval by the Entertainment Permit Administrator. A request for renewal of this permit shall be submitted by the Permittees prior to the conclusion of its term and shall be considered by the Entertainment Permit Administrator in accordance with the requirements of the City's Entertainment Permit Ordinance.
2. This permit is issued to Stephanie Coltrin & Suzanne Dean for the business known as "Shakespeare by the Sea/Little Fish Theatre" located at 514 N. Prospect Ave., Redondo Beach. This Entertainment Permit is non-transferable to any other party or business location, pursuant to Section 4-17.11 of the Redondo Beach Municipal Code. The permit is exclusive to the Permittees and not valid for single event promotions, except those conducted directly by the Permittees, and only if single event promotions are of the type applied for and approved herein.
3. This permit shall be posted in a highly visible location on the premises where the permitted entertainment is to be conducted so as to be readily inspected by representatives of the City and the general public.
4. The business agrees that an Administrative Review by the City shall take place six (6) calendar months after approval of the entertainment permit to evaluate noise complaints, ABC violations, parking issues, and police calls to the business. At that review, the City may alter the hours of entertainment to resolve those issues of noise and police calls for service.
5. Live, amplified entertainment, including dancing, may be provided by a maximum of ten (10) entertainers during the following days and hours:  
**Thursday: 6:00 p.m. to 11:00 p.m.**  
**Friday: 8:00 p.m. to 11:00 p.m.**  
**Saturday: 2:00 p.m. - 5:00 p.m. (matinee) and 6:00 p.m. to 11:00 p.m.**  
**Sunday: 2:00 p.m. - 5:00 p.m. (matinee) and 6:00 p.m. to 11:00 p.m.**
6. All entertainment shall occur within the confines of a fully enclosed building. Entertainment shall be prohibited within outdoor areas of the property.
7. Sound levels greater than ninety (90) dBs are prohibited, unless a conspicuous legible sign is posted outside which states "WARNING, SOUND LEVELS WITHIN MAY CAUSE PERMANENT HEARING IMPAIRMENT" pursuant to Section 4-24.516 of the Redondo Beach Municipal Code.
8. Doors and windows may be open during entertainment, rehearsals, and/or warm up periods until 7:00 PM. If complaints are received from the residents, the doors and windows shall then be closed. Doors and windows shall be closed after 7:00 p.m. during entertainment, rehearsals, and/or warm-up periods. The business will take affirmative steps to mitigate noise complaints received from all environs.
9. The permittees shall ensure that an adequate ventilation system is installed and/or maintained on the premises to promote adherence to the condition to keep all doors and windows closed during specified entertainment hours.
10. If complaints are received and deemed verified by Code Enforcement or the Police Department, the City reserves the right to limit the level of amplification of entertainment activities and/or reduce the hours during which entertainment is provided.
11. Entertainment only as applied for and approved. Exotic adult male and/or female dancers are not allowed. Entertainment provided shall be subject to the regulations of Section 4-17.05 of the Redondo Beach Municipal Code (R.B.M.C.).
12. The posting of flyers, and/or placards, or cards on windshields or similar literature, advertising entertainment activities at the business including promotional events, shall be strictly prohibited within the City of Redondo Beach. Violation of this condition shall be cause of the City Council to take punitive action against the Permittees, including revocation, suspension or modification of this permit.
13. Observe and maintain the required maximum occupancy load. At no time shall the established occupancy load be exceeded. Should this occur, the Fire Department will abate the situation.
14. All aisles and exits shall be kept clear of any obstructions. All exit ways shall not be obstructed in any manner and shall remain free of any material. All panic hardware shall be operable and not be locked, chained, bolted, barred, latched or otherwise rendered unusable.
15. Exterior Fire Department connections and premise address shall be maintained and unobstructed at all times.
16. Any fire alarm and automatic fire protection system shall be tested and have current certification with records forwarded to the Fire Department. All fire extinguishers shall be serviced and tagged by a licensed company.
17. All drapes, drop curtains, and other flammable furnishings used during live performances shall be flame treated and/or be of a non-combustible material and have the approval of the City Fire Marshal. At no time shall pyrotechnics or the use of open flame devices or appliances be allowed.
18. Exit signs shall be illuminated and comply with the Uniform Fire Code (UFC).
19. All fire access lanes and no parking areas shall be unobstructed at all times, unauthorized vehicles will be towed.
20. The permittees and employees of the business shall actively monitor the conduct of the entertainers and patrons to ensure that all

applicable conditions and regulations are followed. Employees shall take immediate action to stop or mitigate any prohibited conduct or activity.

which the City retains sole discretion. The City Manager's decisions shall be final.

21. Under the terms of this Entertainment Permit, the business' employees shall report without delay to the Redondo Beach Police Department all crimes against all persons that occur inside or outside the establishment when known to them. The City reserves the right to review the terms and conditions of this Entertainment Permit based on the failure to report these crimes.
22. A manager, employed by the business, shall be present on the premises at all times that entertainment activities are conducted. Said manager shall be responsible for ensuring compliance with the terms and conditions of this Entertainment Permit, even during promotional events conducted by promoters who are not employees of the permittees.
23. Employees of the business shall have the establishment cleared of all patrons by 12 a.m.
24. The City reserves the right to review the permittees' compliance with the terms and conditions of this Entertainment Permit and, if violations are noted, cause a public hearing to be scheduled and then, if necessary, revoke, suspend, or modify the Entertainment Permit if the conduct of the business staff and/or customers creates problems as defined in these conditions and subject to the regulations of the Redondo Beach Municipal Code.
25. The City may, at its sole discretion adjust entertainment hours, including reductions or increases in days and/or hours of allowed entertainment, allow and/or limit amplification, allow and or limit entertainment locations, allow and/or limit other types of entertainment.
26. The City Manager, or the City Manager's designee, shall act on all matters involving restrictions, extensions, or other provisions identified herein for

27. Pursuant to Section 4-17.06 of the Redondo Beach Municipal Code, the permittees shall post with the City Treasurer, a \$1,500 security deposit to cover the costs of extraordinary police responses from the Redondo Beach Police Department, or from any adjacent agencies if mutual aid is requested to deal with a disturbance. In the event of a required police response, the cost of said response shall be deducted from the bond. If any portion of the bond is expended, the permittee shall replenish the bond to the required amount within five (5) days from the date of written notification by the Chief of Police of a reduction in the amount of the bond. Failure to post the required bond, or to replenish the bond as needed, shall render this Entertainment Permit null and void. This bonding process is not intended to supplant any civil or criminal penalties arising from activities at the business.
