Hello Mr. Margolis and Ms. Hause.

Thank you for the email letting me know about tonight's City Council meeting, and the consent calendar item that seeks Council approval to consolidate certain City Commissions. First, let me say that I am opposed to this consolidation. As you both know, City Commissioners serve on the commissions voluntarily and do not charge the city for their time or volunteer efforts. City staff is paid, as well as the Mayor and Council members. Before the City considers the cost of staff to oversee these commissions, it should also calculate the time invested by citizen volunteers in these commissions and their volunteer efforts. Many are professionals, and professionals charge money when they work.

When Bill Brand was Mayor, it was his goal to fill as many seats on commissions as he could. Bill favored public participation. We all know his time ran out. This attempt to eliminate commissions is directly in conflict with what Bill did all the years he was Mayor. Bill sought public participation on city commissions and I don't think you would find him advocating elimination of commissions. You can label this latest move by Jim Light a consolidation, but really, it is elimination of public participation by Jim Light. Let me be quite frank about this latest Jim Light maneuver: I do not think there's been any public outcry about these commissions being unnecessary. Let's remember that Jim Light is not an elected Mayor. He was only appointed on a split 3-2 vote of the Council after his friends got up and lied to the Council that Bill Brand said he wanted Jim Light to appoint him as Mayor after Bill passed. Jim Light was not Bill's choice to succeed him as Mayor. I know. I was Bill's lawyer for the last seven years of his life and not once did Bill ever suggest his replacement be Jim Light. Bill had someone else in mind. We spoke daily, and usually multiple times a day. That person's identity is not really at issue now because the appointment has been made. He (Light) ran twice for the District 1 Council seat and lost both times. This should tell you that he is out of touch with the public. Additionally, Jim Light was appointed to the Public Works Commission years ago, and when he did not like it, he quit.

I did make comments last week to you both, and I noticed that my comments were not included in the staff report submitted for tonight's agenda. What's really appalling in this latest act of eliminating public participation in city affairs, is the dismissive manner in which this decision is going to be made - on the consent calendar. No one at City Hall could be bothered to put this on as a public hearing. Really ?

Hello Commissioners-

I'm following up on the email below.

As shown below, at its meeting tomorrow tonight (July 9), City Council will consider a proposal to amend the Municipal Code to merge four city commissions (including the Historical Commission) into one new commission. This item is currently scheduled as a Consent Item. That means that it will not be discussed unless a council member or a member of the public requests that it be "pulled" from the consent agenda and discussed. If you click on the link below (24-119), you'll find letters in opposition to the proposal submitted by the Library Commission and the Recreation and Park Commission. If you want council to know how you feel about this proposed change, you should attend and speak at tomorrow's meeting. This is the "first reading" of the ordinance, so technically, the item will return to council one more time, but expressing your opinions tomorrow would be ideal. Consent items are considered early in the agenda, so you shouldn't have to wait a long time to speak.
