STAFFING & COST STRUCTURE Two Staffing Models, Cost Gap

- City Employed: \$18,630 Yearly
 City Pays \$20-\$25/Hour
- Contracted: \$29,792 Yearly
 Contract Rate: \$36.78/Hour
- City Staff Used When Available
- Contract Bridges Staffing Gaps





CROSSING GUARD PROGRAM Proposed Funding for 27 Sites

- Core Budget (General Fund): \$212, 600 (12 Sites)
- Additional One-Time Funds: \$367,000 (15 Sites)
 - \$205,000 for Part-Time Staff
 - \$162,000 for Contract Services

Plan-check Operations Improvements

• Current

- 2 fulltime in-house plan checkers
- Approximately 20% outsourced to third party (paid hourly)
- Average review 6-8 weeks per submittal

Proposed

- 2 fulltime in-house plan checkers
- Outsource 70% to third party
- 60/40 plan-check revenue share
- Average review 1-2 weeks
- Plan checkers more available to assist customers
