NOTICE IS HEREBY GIVEN THAT A PUBLIC HEARING WILL BE HELD BEFORE THE CITY COUNCIL OF THE CITY OF REDONDO BEACH ON THE FOLLOWING MATTER. ANY AND ALL INTERESTED PERSONS MAY APPEAR AND BE HEARD.

SUBJECT OF THE HEARING: To receive and file the 2025 Riviera Village Advisory Board's Annual Report, reappoint the Board of Directors for the Riviera Village Association to serve as the advisory board for the Riviera Village Business Improvement District during calendar year 2026, consider the proposed levy of an assessment upon the businesses within the Riviera Village Business Improvement District for Calendar Year 2026, and direct the advisory board to prepare a report for 2026

PUBLIC HEARING: The public hearing on this matter will take place before the City Council on Tuesday, November 18, 2025 at 6:00 p.m., or as soon thereafter as possible, in the Redondo Beach City Council Chamber, 415 Diamond Street, Redondo Beach, California, or for public participation by Virtual Meeting. The meeting will also be livestreamed on the City's website at www.redondo.org/RBTV, YouTube at https://www.youtube.com/c/CityofRedondoBeachIT, and broadcast live through Spectrum Channel 8 and Frontier Communications Channel 41. Members of the public may participate during the meeting as outlined below.

PUBLIC COMMENT: There will be three options for public testimony during the meeting as outlined below:

- (1) In person oral testimony can be provided by attending the meeting in the City of Redondo Beach City Council Chamber at the address noted above.
- (2) Interested persons may submit a written eComment through the City's agenda webpage at https://redondo.legistar.com/Calendar.aspx. Specific instructions for eComment will be provided on the agenda cover page when it is released at least 72 hours prior to the meeting. eComments may be read out loud by City staff during the public hearing and are limited to 3 minutes in length (up to 2200 characters). Only one eComment per person.
- (4) Oral public testimony can be provided live by joining the virtual Zoom meeting by computer or phone-in. Registration is required. The registration link will be provided on the agenda coversheet when it is released at least 72 hours prior to the meeting.

A person may either comment live or submit an eComment but cannot do both. For those that cannot participate during the public hearing, written comments for the City Council on this matter may be submitted by email to cityclerk@redondo.org. Written comments will be accepted up to 3:00 p.m. the day of the public hearing, November 18, to allow time for distribution to the City Council as a Blue Folder item.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
REDONDO BEACH, CALIFORNIA, DECLARING ITS INTENTION
TO LEVY AN ASSESSMENT AGAINST BUSINESSES WITHIN THE
RIVIERA VILLAGE BUSINESS IMPROVEMENT DISTRICT FOR
CALENDAR YEAR 2026 AND SETTING A TIME AND PLACE FOR
HEARING OBJECTIONS THERETO

WHEREAS, the Parking and Business Improvement Area Law of 1989, California Streets and Highways Code Sections 36500 et seq. (the "Law"), authorizes the City Council of the City of Redondo Beach to establish a business improvement district and to levy an assessment against businesses within such business improve- ment district which is in addition to any assessments, fees, charges, or taxes imposed in the City; and

charges, or taxes imposed in the City; and WHEREAS, pursuant to the Law, the City Council adopted Ordinance No. 2922-03 establishing the Riviera Village Business Improvement District (the "District") in the City of Redondo Beach: and

WHEREAS, by previous resolution, pursuant to Section 36530 of the Law, the City Council appointed certain individuals to serve as the Advisory Board for the District (the "Advisory Board") and directed the Advisory Board to prepare and file with the City a report in connection with the proposed levy of an assessment against businesses within the District for Calendar Year 2025; and

WHEREAS, in accordance with Section 36533 of the Law, the Advisory Board prepared and filed with the City Clerk a report entitled "Riviera Village Business Improvement District Annual Report 2025" (the "Report"), and, by previous resolution, the City Council preliminarily approved such report as filed: and

resolution, the City Council preliminarily approved such report as filed; and WHEREAS, the boundaries of the District includes all territory described in Exhibit **Air state, het perton and incorporated hearing by reference.

Exhibit "A" attached hereto and incorporated herein by reference.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO
BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the City Council hereby declares its intention, in addition to any assessments, fees, charges or taxes imposed by the City, to levy and collect an assessment against businesses within the District for Calendar Year 2026 (January 1, 2026 to December 31, 2026. Such assessment is not proposed to increase from the assessment levied for calendar year 2025. The method and basis of levying the assessment is set forth in Exhibit "B" attached hereto and incorporated herein by

SECTION 2. The types of improvements to be funded by the levy of an assessment against businesses within the District are the acquisition, construction, installation or maintenance of any tangible property with an estimated useful life of five years or more. The types of activities to be funded by the levy of an assessment against businesses within the District are activities which benefit businesses located in and operating in the District.

SECTION 3. Non-profit organizations with documentation of non-profit status shall not be subject to this assessment.

SECTION 4. That the City Council hereby fixes the time and place for a public hearing on the proposed levy of an assessment against businesses within the District for Calendar Year 2026 as follows:

Time: 6:00 p.m., or as soon thereafter Date: as practical November 18, 2025 Place: City Council Chambers 415 Diamond Street Redondo Beach, California 90277

At the public hearing, the testimony of all interested persons regarding the levy of an assessment against businesses within the District for Calendar Year 2026 shall be heard. A protest may be made orally or in writing by any interested person. Any protest pertaining to the regularity or sufficiency of the proceedings must be in writing and shall clearly set forth the irregularity or defect to which the objection is made.

Every written protest must be filed with the City Clerk at or before the time fixed for the public hearing. The City Council may waive any irregularity in the form or content of any written protest and at the public hearing may correct minor defects in the proceedings. A written protest may be withdrawn in writing at any time before the conclusion of the public hearing.

Each written protest must contain a description of the business in which the person subscribing the protest is interested sufficient to identify the business and, if a person subscribing is not shown on the official records of the City as

the owner of the business, the protest shall contain or be accompanied by written evidence that the person subscribing is the owner of the business. A written protest which does not comply with requirements set forth in this paragraph will not be count- ed in determining a majority protest (as defined below).

count- ed in determining a majority protest (as defined below).

If, at the conclusion of the public hearing, written protests are received from the owners of businesses in the District which will pay 50 percent or more of the assessments proposed to be levied and protests are not withdrawn so as to reduce the protests to less than that 50 percent, there is a majority protest, no further proceedings to levy the proposed assessment, as contained in this resolution of intention, shall be taken for a period of one year from the date of the finding of a majority protest by the City Council.

If the majority protest is only against the furnishing of a specified type or types of improvement or activity within the District, those types of improvements or activities shall be eliminated.

SECTION 5. For a full and detailed description of the improvements and activities to be provided for Calendar Year 2025, the boundaries of the District and the proposed assessments to be levied against the businesses within the District for Calendar Year 2026, reference is hereby made to the Riviera Village Business Improvement District Report 2025. The Report is on file with the City Clerk and open

SECTION 6. That the City Clerk is hereby authorized and directed to provide notice

of the public hearing in accordance with law.

SECTION 7. That the City Council finds that this is not a project under the California
Environmental Quality Act and, therefore, no environmental impact assess-ment is

SECTION 8. That the City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.

Assessment of Formula (Method and Basis of Assessment)

The proposed method and basis of levying the assessment for funding the improvements and activities of the Riviera Village Business Improvement District shall be that all license holders (with the exception of non-profit organizations who elect not to participate in the BID) will annually be assessed a base of \$125 plus a fee of \$34 per employee per year to a maximum assessment of \$1.400 per year. Those licensees who are property owners and are assessed on their business license fees on a per unit basis shall pay BID assessments of \$125 plus \$34 per rental unit per year with a maximum assessment of \$1.400 per year. For purposes of this assessment the number of employees will be that reported on City Business
