




The 2024 - 2025 School District Report is here!



Support Youth Mental Health!

allcove Beach Cities is a place where youth belong, chooses their support and thrives. This welcoming space is youth-designed, with the mission to reduce stigma, create community and provide accessible, connected services to support the health and wellbeing of young people.

Since opening in late 2022, allcove Beach Cities has welcomed 1,558 young people into its services (as of June 30, 2025 — 32 months of operation).

Where they're from:

Redondo Beach: 548 young people (35.2%)
Manhattan Beach: 223 young people (14.3%)
Hermosa Beach: 81 young people (5.2%)
Beach Cities total: 852 young people (54.7%)

Just across the street from the Campus, Torrance has the second-highest enrollment with 263 young people (16.9%). Together, the Beach Cities and Torrance account for 1,115 of the 1,558 total enrollees — 71.6%





BCHD reports that:

ALLCOVE non-resident use is: 44% to 49%
Center for Health and Fitness non-resident use is: 25%
AdventurePlex non-resident use is: over 50%

Yet, BCHD has no idea how much of our taxes, facilities, land, and staff are "spent" on non-residents.

Imagine the pitchforks and torches if any City was spending 25% to 50% of its services on NON-RESIDENTS. Surely that would NEVER happen. Yet, that's exactly what BCHD does.

We have a serious problem with controls at BCHD and the 3 cities need to get off the dime and support responsible use of resident taxpayer funds and asset revenues by BCHD.


BCHD filed a draft Pre-CUP that stated the 4-story hospital was 51.5-feet tall.
