

# **Overall Sentiment**





# **Overall Sentiment**





The schedule for replacement furnaces and hot water heaters for existing homes is also reasonable. This does not mean that people have to change their appliances and panels by 2027 or 2029. If you like your gas appliance and it is still working, then you can keep it. However, if your appliance breaks and you are looking for new

replacements, you will find that the new heat pumps on the market are so much better than old gas ones. Our HVAC installer says that everyone is opting for heat pumps instead of gas furnaces because they are just better-performing.
