

**RESOLUTION NO. CC-2310-105**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL YEAR 2023-2024 BUDGET MODIFICATION TO APPROPRIATE \$500,000 OF ALLOCATED STATE OF CALIFORNIA GRANT FUNDS FROM THE JUDICIAL COUNCIL TO THE INTERGOVERNMENTAL GRANT FUND.**

WHEREAS, it is the intention of the City Council of the City of Redondo Beach (“City Council”) to review the adopted budget from time to time; and

WHEREAS, the City of Redondo Beach’s adopted budget needs to be modified to appropriate monies to fund necessary expenditures; and

WHEREAS, in the Fiscal Year 2022-2023 Budget, Assemblymember Al Muratsuchi secured California Grant Funds in the amount of \$500,000 (Grant Funds) for the City of Redondo Beach Outdoor Homeless Court Program and Enhanced Response to Homelessness Program through Assembly Bill 178 (AB 178); and

WHEREAS, on August 9, 2023, Assemblymember Muratsuchi personally appeared at the City Council meeting to present the Grant Funds to the City of Redondo Beach; and

WHEREAS, AB 178 states that the Grant Funds are to be allocated by the Judicial Council; and

WHEREAS, the City has approved the receipt and appropriation of past funding for similar programs.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the amounts allocated in the budget of Fiscal Year 2023-2024 and the amounts required to meet conditions which have arisen during the budget year require a modification in the budget appropriation; and, upon recommendation of the City Manager, the budget appropriation as adopted for Fiscal Year 2023-2024 is modified as follows:

Five hundred thousand dollars (\$500,000) in California Grant Funds from the California Judicial Council shall be appropriated to the Intergovernmental Grant Fund and expended for the Redondo Beach Homeless Court and Enhanced Response to Homelessness Program.

SECTION 2. That pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed and instructed to correct the budget records of said City for Fiscal Year 2023-2024 in accordance with the above modification.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
