

RESOLUTION NO. CC-2403-012

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
REDONDO BEACH, CALIFORNIA, AWARDING A CONTRACT
TO HARDY & HARPER, INC., A CALIFORNIA CORPORATION,
IN THE AMOUNT OF \$213,800 FOR ANITA STREET AT PCH TO
MARIA AVE STREET IMPROVEMENTS (WESTBOUND
CHANNELIZATION) PROJECT, JOB NO. 41240**

WHEREAS, Anita Street at Pacific Coast Highway ("PCH") to Maria Avenue, within the City of Redondo Beach ("City"), needs Street Improvements (Westbound Channelization); and

WHEREAS, on November 7, 2023, the City Council of the City of Redondo Beach ("City Council") approved the Plans and Specifications for the Anita Street at Pacific Coast Highway to Maria Avenue Street Improvements (Westbound Channelization), Job No. 41240 (the "Project"), and authorized the City Clerk to advertise for competitive bids; and

WHEREAS, on February 15, 2024, bids for this Project were received and publicly opened in the City Clerk's Office; and

WHEREAS, Hardy & Harper, Inc., a California corporation, is the lowest responsible bidder for this Project, as more particularly described in the Plans and Specifications thereof, and incorporated herein by reference, and is awarded the contract for this Project in the amount of \$213,800; and

WHEREAS, Hardy & Harper, Inc. shall provide all applicable insurances and bonds to the City for approval prior to the execution of the contract; and

WHEREAS, sufficient Capital Project Funds have been appropriated for the Project in the adopted Fiscal Year 2023 to 2024 Capital Improvement Program Budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council of the City of Redondo Beach, California, awards the contract for the Anita Street at Pacific Coast Highway to Maria Avenue Street Improvements (Westbound Channelization), Job No. 41240, to Hardy & Harper, Inc., in the amount of \$213,800, on the condition that all applicable insurances and bonds shall be provided to the City for approval prior to the Mayor executing the contract on behalf of the City.

SECTION 2. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
